To Save Energy.

Old refrigerators and freezers use three times as much electricity as new energy-efficient models. Refrigeration is one of the largest energy-consumers in residential settings.

To Save Money.

You could save an average of 25% in operating costs each month by replacing your old or inefficient refrigerator with a new ENERGY STAR®-qualified unit.

To Protect the Environment.

When recycling old refrigerators and freezers, 98% of their materials are reused, and harmful refrigerants are removed in an environmentally-safe manner. The alternative is to let it sit in a landfill.

ENERGY STAR®-qualified refrigerators require about half as much energy as models manufactured before 1993. They provide energy savings without sacrificing the features you want.


ENERGY STAR®-qualified refrigerator models use high efficiency compressors, improved insulation, and more precise temperature and defrost mechanisms to improve energy efficiency.

ENERGY STAR®-qualified refrigerator models use at least 15% less energy than required by current federal standards, and 40% less energy than the conventional models sold in 2001.

ENERGY STAR®-qualified freezer models use at least 10% less energy than required by current federal standards.
