Tony Brandl from Hake Road appeared before the Board with concerns of the drainage issue relating to the proposed subdivision. He has dealt with a drainage problem for the last 5 years and is very concerned that the subdivision will only increase the problem. Building Inspector Donnal Folger explained that the Village Engineers are evaluating drainage relative to the subdivision. Village Attorney Daniel D. Barbara Kaufman came before the Board with several complaints from neighbors regarding the metro paving project preformed by Suit-Kote in the Sylvan/Crescent Loop. Superintendent Robert Kowalik explained the repair process which can take a full two weeks for the material to settle and smooth out.
