
Design Concept:


Dear Board Members:

As a project manager and designer of R.E. McNamara Enterprises, a Clarence based professional remodel and build company, I have been requested by the Yu Family to provide consultation on the feasibility of building plans to expand their family food establishment, The Hollow Bistro & Brew located at 10641 Main Street in Clarence. The two plans are as follows: 1) rehab, or 2) demolish and rebuild, the buildings immediately adjacent to their current establishment.

After reviewing the buildings I found a harsh lack of congruence between the several unattractive buildings that have in time been connected to the original brick building – both in interior and exterior design, and integrity of construction - I wondered how the additions were attached given that floors between rooms were sloping and exceptionally uneven, and what kind of foundations were supporting these buildings. Moving forward with a rehabilitation plan would call for substantial deconstruction to answer questions pertaining to foundation problems – and these answers could ultimately result in rebuilding foundations. Additionally, the interiors of these buildings were in very poor condition, and not genuine (as witnessed by fake, hollow wood support beams, foyer staircase, delaminating floors, and other design elements synonymous with building cheaply). Rehabilitating the buildings and working within the current footprint and mechanical infrastructure also stifles developing a plan congruent with restaurant needs and supporting demand for more seating tables.

All of these points are in favor of demolishing the buildings and constructing a new building fit for the restaurant/food business. This is in the best interest of the Yu Family and the Town of Clarence.


Demolition of the existing structure will result in a physical change to the project site. This action will be mitigated by the proposed rehabilitation of the property in a form that will match the existing architectural style of the adjoining historic structure and provide the necessary in fill to maintain the overall character of Clarence Hollow.


