Proof of Citizenship OR Lawful Status in US

Original or Certified copy of US Birth Certificate
(Not Hospital Certificate)

Valid US Passport

Original Certificate of Citizenship

Original DOS Consular Report of Birth Abroad

For REAL ID Only: Permanent Resident Card, Valid Foreign Passport

AND Proof of Identity. You Must Have ONE

Existing New York State Driver's License
 OR
 6 Points of Identity *(see D.M.V. checklist)*

NOTE: If Name on Birth Certificate is different from Proof of Identity, you **MUST** bring Marriage Certificate or Court Issued Name Change Document

AND an Original Social Security Card OR one of the following issued within the past year

*Federal or NY State Income Tax form W-2 *(with SSN)*
 *US Computer Printed Pay Stub *(with name & address and SSN)*
 *Federal or NYS Income Tax or Earning Statement -1099 or 1098 *(with SSN) - These are only valid if SS# previously verified by DMV*

AND Proof of New York State Residency. You must have 2 DIFFERENT ORIGINAL Proofs

- *Utility Bill With Name and Address *(issued within 120 days)*
- *Original Credit Card Statement on letterhead *(issued within 120 days)*
- *Cancelled Check *(issued within 120 days)*
- * Postmarked mail dated in last 90 days
- * Proof of Current Mortgage or Property Deed
- * New York State Pistol Permit
- * Selective Service Card
- * New York State Professional License
- * SSI Award Statement or Retirement Statement
- * Welfare Benefit Statement
- * Assisted Living or Nursing Home Statement
- * Military Orders that are still in effect
- * Report Card with Photo ID
- *Certificate of Residence *(see MV-44NYR for more information)*

- *Current Proof of Homeowners/Renters Insurance *(Policy, Proof of Claim)*
- * Current Proof of Health Insurance Coverage *(with current address preprinted)*
- * Annual Social Security Statement *(for the current year)*
- * New York Certificate of Title
- * Bank Statement Issued *(within the last 120 days)*
- * Computer Printed Pay Stub *(with name and address issued within 120 days)*
- * Life Insurance Policy or Current Statement *(with address issued within 120 days)*
- * Voter Registration Notification Card *(issued within one year)*
- * Residential Lease *(issued within one year)*
- * Jury Duty Notice *(issued within one year)*
- * Photo College ID with Transcript *(issued within one year)*
- * Unemployment Benefit Statement *(issued within one year)*
- * Federal or New York State Income Tax W-2 with S.S.N. *(issued within one year)*
- * Federal or New York State Income Tax or Earning Statement (1099, 1098)
- * Property or School Tax Bills or Receipts for the current Year. Must reflect the current address both on the mailing portion and portion stating what property is being taxed
- * Medical Examiner's Certificate with New York State address and signature issued within one Year *(form used for CDL physical requirement)*
- * DMV Form MV-45 *(if under age 21)*
