

## Liquor License Publication

**9 NYCCR 104.1:** Must publish once a week for two successive weeks in a daily or weekly newspaper (as defined by NY General Construction Law §60) to be designated by the County Clerk, in the city, town or village in which the prospective licensed premises are located; if there be none, in the county where the proposed premises are to be located once a week for two successive weeks in a daily or weekly newspaper.

NOTE: Asterisk after name denotes weekly publication.
