

## ERIE COUNTY SEWER DISTRICTS - LATERAL REPLACEMENT PROGRAM

The Department of Environment and Planning, Division of Sewerage Management (DSM) has an on-going infiltration and inflow (I&I) program aimed at minimizing and eliminating stormwater and groundwater from entering the sanitary sewer system. I&I takes away from the system capacity. It also increases the amount of flow conveyed through the system and adds to the cost to treat the flows. Ultimately, this impacts the ratepayer.

Building sewer laterals are the private sewerlines that a property owner is responsible for (from the building to the main sewerline). Older laterals (many built prior to 1975) are often made of clay tile pipe. This material is susceptible to root intrusion issues through joints and fractures in the pipe allowing groundwater and wet weather infiltration into the sanitary sewer, thus increasing the overall flows in the system.


Legally the DSM cannot do repair work on private property. Due to the legal restrictions and the increase in I&I issues, the DSM has a program in place for all Erie County Sewer Districts (ECSD), to replace older and deficient private property laterals. This program requires developers of new projects that will add sanitary sewage flow to the sewer system to remove I&I by replacing older or deficient laterals within that Sewer District. A developer will be given a specific number of laterals to replace, based on the size of their proposed project. The developer will furnish pipe material, stone, installation of the lateral, and fill the trench to a mounded formation. Private laterals in this program will be replaced to the main sewer (if it is before the edge of pavement) or to the edge of pavement with a clean out access point (if the sewer is in the street), as road cuts are not part of the program. The property owner is responsible for all final restoration work and costs including, but not limited to: top soil, grass reseeding, watering, landscaping, sidewalks, pavement, fences, long term settlement (removing excess or adding additional fill), etc. However, the replacement of the lateral by the developer could save a property owner an average of \$3,000 in material and installation costs and increases the value of the property.

Existing property owners who may have older installations, leaking pipes, and/or chronic problems with their lateral may sign up for the program. To be part of the program, an owner needs to sign a release form, have a house inspection completed by the DSM to verify connections are in accordance with construction standards, and then they will be placed on a waiting list that is generated on a first come basis. **Please note that the DSM cannot determine the duration of the waiting period, as the work on your lateral is based on the developer's construction schedule. This could take anywhere from months to years for completion.** Due to this, a homeowner should consider replacing their building sewer at their own cost to address issues with their lateral while waiting for the Developer's program to take place. The DSM will make every effort to have the lateral replaced as soon as possible. The diagram below shows the placement of a typical house lateral and main sewerline.
