Repaired (3) light fixtures in and outside the hypo building. Installed a new fixture on the washdown pump building to replace an un-repairable light.

Pleasantview

The generator engine starter was repaired, and the engine battery replaced.

District 4 Offices/Garages

The HVAC cooling tower spray pump seized. It was determined to be un-repairable and a new pump was purchased and installed.

The cooling tower sump fill line flex fitting developed a leak. A temporary repair was made until a new fitting can be purchased and installed.

The existing vehicle was disassembled and removed in preparation for the installation of a new lift.

Removed pump 1 for repair and replaced with spare.

Removed debris from pump 2.
