- 2. <u>Approval of Minutes</u>: The minutes of the January 17, 2014 Board of Directors Meeting were presented and reviewed. A motion made by Donna J. Estrich to approve, seconded by James Comerford Jr., and unanimously carried as approved.

- 4. 2013 Pilot Project Update:
  - **45-55 Pyle Court, Tonawanda**: BENLIC/County Assistant Attorney Martin Polowy negotiating with Town of Tonawanda regarding terms of transfer from BENLIC to the Town.
  - 39 Fowler Street, Tonawanda: RFP is due back March 7, 2014; the Board will be able to review bids at the next scheduled Board meeting.
  - *44A Windwood Court, Cheektowaga*: Title search underway. All lien holds cannot be notified therefore notification will be done by publication. Judgment is scheduled for May and sale scheduled for June.

- **59 North Main Street, Angola:** Title search underway. Lien holds have been served, anticipated judgment in April and sale possible in May.

# 5. OAG Contract Update:

- Contract Review: Scope of Work highlighting the following items.
  - o Demolition of 50 properties in the City of Buffalo
  - o Demolition of 5 properties in the City of Lackawanna
  - Rehabilitation of approximately eight (8) properties throughout Erie County, including any in the Cities of Buffalo and Lackawanna.
  - o Side lot Program
- Contract Review: Jocelyn reviewed several sections of the 172 Page OAG contract with the Board.
- Discuss process of subcontracting with partner cities: The City of Buffalo contract must be finalized first to meet the timeline of demolishing 50 homes starting this Q1 of the grant period. James Comerford, Jr. agreed to email Jocelyn Gordon the City's typical vetting process for contractors. Martin Polowy agreed to begin drafting the Agreement for completion in one week. All parties were reminded that the OAG Project Manager (i.e. Community Enterprise Partners, has the authority to approve all subcontracts over \$100,000.
- The Land Bank Working Group will continue to identify more properties for rehab portion of grant.
