RE: Replenishment of E-Z Pass Tags

In 2012, your Honorable Body approved a resolution authorizing the Erie County Clerk's Office to act as a retail sales agent for the NYS Thruway Authority for the sale of E-Z Pass Tags (Comm. 12E-17-2012). The Clerk's Office began selling the tags in October 2012. When we prepared our 2013 Budget we did not have any data to project sales, and we conservatively estimated the amount in our 2013 Budget. We are pleased to report that the demand for these tags is much greater than anticipated and the attached resolution seeks approval to adjust the 2013 budget to allow for the purchase and sale of additional tags.

### **SUMMARY**

It is recommended that the Erie County Legislature authorize a budgetary amendment to the Clerk's 2013 Budget to allow for the purchase and sale of additional E-Z Pass Tags.

### **FISCAL IMPLICATIONS**

Positive – Expense to purchase the tags is completely offset by the sale of the tags, which results in additional revenue to the County's general fund.

### **REASONS FOR RECOMMENDATION**

Sale of the E-Z Pass Tags by the County Clerk's Office has been met with positive results.

### **BACKGROUND INFORMATION**

In 2012, the Legislature approved a resolution authorizing the Erie County Clerk's Office to act as a retail sales agent for the NYS Thruway Authority for the sale of E-Z Pass Tags (Comm. 12E-17/2012) and we began selling EZ Pass tags in October 2012. At the time the 2013 Budget was prepared, we had no data to accurately project sales. Sale of these tags has been met with great success; at the end of April we have sold 403, and had allocations available to purchase 500 tags. Our projections indicate that an allocation to purchase an additional 400 tags is needed for calendar year 2013. A budgetary adjustment is needed to allow for the purchase and sale of these additional 400 tags.

### **CONSEQUENCES OF NEGATIVE ACTION**

We will run out of tags to sell and the County will lose much needed revenue.

### **STEPS FOLLOWING APPROVAL**

Budgetary adjustments will be made and the E-Z Pass Tags will be purchased from the NYS Thruway Authority for sale by the Clerk's Office.

WHEREAS, the Erie County Legislature previously authorized the Erie County Clerk to act as a retail sales agent for the NYS Thruway Authority in the sale of E-Z Pass Tags (Comm. 12E-17/2012); and

WHEREAS, the sale of these tags has been met with great enthusiasm from the public that visit the County Clerk’s Auto Bureau and Clerk’s Registrar Office; and

WHEREAS, the Erie County Clerk purchases E-Z Pass Tags at a unit price of \$21.00 and is authorized to sell them to the public at \$25.00 per tag, with the County retaining \$4.00 in revenue for every tag sold; and

WHEREAS, no additional resources are necessary to offer these tags for sale; and

WHEREAS, the Clerk’s 2013 Budget needs to be adjusted to allow for the unanticipated increase in the sale of these tags.

RESOLVED, that the Erie County Legislature does hereby authorize the following budgetary adjustment in the 2013 Budget:
