Local Law No. 1 of the year 19 92

A local law amending Erie County Local Law No. 1-1959, as amended, constituting the Erie County ^(Insert Title) Charter in relation to restricting increases of salaries of elected officials.

Be it enacted by the ERIE COUNTY LEGISLATURE of the _____

Section 1. Subdivision ~~a~~ of Section 202.3 of Article II of Local Law 1-1959, constituting the Erie County Charter, as amended, is hereby amended to read as follows:

The county legislature shall specifically establish the effective date of any adjustments in the salaries of elected county officials. No increase in the salary of an elected official shall be permitted for any fiscal year in which there is an increase in the real property tax levy over the tax levy of the previous fiscal year.

Section 2. This amendment shall be submitted for approval of the electors at a special election to be held not later than ninety days following the adoption of this amendment and shall apply to any real property tax levy following its approval by the affirmative vote of a majority of the qualified electors of the county voting upon this amendment.
