LOCAL LAW INTRO. NO. 6-2011

A LOCAL LAW rescinding a Local Law in relation to regulation of home healthcare services

provided to Erie County residents pursuant to contracts awarded by the County of Erie.

BE IT ENACTED BY THE LEGISLATURE OF ERIE COUNTY AS FOLLOWS:

SECTION 1. LEGISLATIVE INTENT. Local Law No. 14-2004 creates certain local

requirements that govern home healthcare services in the Erie County. These requirements are

redundant to requirements of New York State Law. This redundancy increases costs to home

healthcare providers as well as unnecessarily strains county resources. Repeal of the law will

decrease costs to taxpayers and home healthcare providers with no effect on the provision of

home healthcare services.

SECTION 2. Local Law No. 14-2004, which undertook and exercised its regulatory authority

with regard to activities subject to regulation of home healthcare services, be and the same

hereby is rescinded in its entirety.

SECTION 3. Hereafter the regulations set forth by the State of New York in regulation of home

healthcare services shall provide the regulatory framework for and govern home healthcare

SECTION 4. This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State, and in accordance with Section 27 of the Municipal Home Rule Law shall be filed within twenty (20) days after this Local Law shall have been adopted.
