WHEREAS, the Erie County Department of Health requires the re-creation of four positions to address a major void in the professional and administrative operations of the department; and

WHEREAS, in order to fill this void and efficiently provide required services, it is necessary to re-create the positions of Special Assistant-Commissioner of Health JG X, Chief County Toxicologist JG XVI, Assistant Toxicologist JG IX , and an Associate Public Health Engineer JG XV; and

WHEREAS, due to the budgetary restructuring that was implemented within the department, the position of Special Assistant-Commissioner of Health is necessary to efficiently oversee all administrative functions associated with the Commissioner's office and to provide support to departmental divisions, combined with the recently added responsibilities of processing Freedom of Information requests, and insuring both HIPAA and contract compliance activities are met; and

WHEREAS, the Erie County Department of Health maintains a Public Health Engineering office that is responsible for:

- Regulatory oversight of public drinking water supplies
- Plan review/approval and permitting of subdivision water and sewer construction projects
- Plan review/approval and permitting of commercial and residential private sewage construction;

and

WHEREAS, the position of Associate Public Health Engineer (JG XV) has historically provided the professional engineer (PE) license and supervisory responsibility of the Public Health Engineering office; and

WHEREAS, the re-creation of this position will enhance the ability of the Department to assess and respond to threats to public drinking water supplies, will positively impact economic development across Erie County by enhancing approvals for commercial and residential construction projects; and

WHEREAS, the need to re-create the positions of Chief County Toxicologist JG XVI, and Assistant Toxicologist JG IX, became necessary when it was recently discovered that the Toxicology Laboratory within the Erie County Medical Examiner's Office would be in jeopardy of losing accreditation from the American Board of Forensic Toxicology (ABFT) and the New York State Commission on Forensic Science; and

WHEREAS, such action would seriously diminish the Laboratory's credibility in criminal court proceedings which would ultimately jeopardize criminal investigations and prosecutions; and

WHEREAS, the Erie County Health Department desires to fill these positions with qualified and experienced professionals; and

WHEREAS, funds have been identified in the Adopted 2011 Budget.
