LOCAL LAW NO. ____-2011

LOCAL LAW INTRO. NO. 6-2011

A LOCAL LAW rescinding a Local Law in relation to regulation of home healthcare services provided to Erie County residents pursuant to contracts awarded by the County of Erie.

BE IT ENACTED BY THE LEGISLATURE OF ERIE COUNTY AS FOLLOWS:

SECTION 1. LEGISLATIVE INTENT. Local Law No. 14-2004 creates certain local requirements that govern home healthcare services in the Erie County. These requirements are redundant to requirements of New York State Law. This redundancy increases costs to home healthcare providers as well as unnecessarily strains county resources. Repeal of the law will decrease costs to taxpayers and home healthcare providers with no effect on the provision of home healthcare services.

SECTION 2. Local Law No. 14-2004, which undertook and exercised its regulatory authority with regard to activities subject to regulation of home healthcare services, be and the same hereby is rescinded in its entirety.

SECTION 3. Hereafter the regulations set forth by the State of New York in regulation of home healthcare services shall provide the regulatory framework for and govern home healthcare services in the County of Erie.

SECTION 4. This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State, and in accordance with Section 27 of the Municipal Home Rule Law shall be filed within twenty (20) days after this Local Law shall have been adopted.

WHEREAS, cyber-bullying has a significant impact on students who are not able to escape their tormentors outside of the school and it thereby affects their lives and performance in school; and WHEREAS, the additional pressure of cyber-bullying, it has been shown, increasingly leads young people to take drastic actions, such as suicide, to escape the pain they feel from the continual bullying both in school and at home; and

WHEREAS, school districts, parents and law enforcement are in need of guidance and tools to combat this problem and to prevent tragic suicides due to the effects of bullying.

RESOLVED, that the Erie County Legislature strongly encourages the New York State Legislature and Governor Cuomo to approve legislation that would address the issue of bullying, particularly cyber-bullying that occurs outside of the school setting; and be it further

WHEREAS, moving the William Street operations to another location outside the area is a cost-prohibitive move that would negatively impact the economy of Erie County; and

WHEREAS, the post office in Lackawanna is being considered for closure without proper notification to the public it serves prior to a public hearing on the matter; and

WHEREAS, specific objections include the failure by the postal service to properly notify the public by not delivering questionnaires to individuals and businesses that will be affected by the closure; the proposal and request for comments are not clearly visible to the public at the Lackawanna post office; the notice of and community meeting were not publicized through local media; the community meeting details were incomplete and conflicting deadlines were given for community feedback; and

WHEREAS, given the inadequacy that has been documented in the above areas, it is the responsibility of the Postal Service to address these issues before any public hearing can be held.
