Col. Matt Urban Human Services Center of WNY and the West Side Neighborhood Housing Services in Erie County; and

WHEREAS, the County desires to subcontract with Belmont Housing Resources for WNY for an amount not to exceed \$1,493,376 for the period 1/1/12 - 12/31/14 for the purpose of preparing work and bid specifications in homes to receive lead hazard control work, and awarding competitive bids for hazard control work, including labor and supply costs, to qualified contractors, and monitoring work progress and quality of contractors who are successful in receiving bids and coordinating and accounting for the matching contributions to the proposed work at participating homes; and

WHEREAS, the County desires to subcontract with UNYSE, for an amount not to exceed 334,800 for the period 1/1/12 - 12/31/14 for the purpose of providing prompt full and partial clearance sampling and reporting; and

WHEREAS, the County desires to make personnel adjustments which result in no net gain or loss in number of positions, will utilize available funding efficiently and effectively to accomplish the work plan goals.

WHEREAS, the United States Postal Service recently announced it was considering a number of dramatic cost cutting measures in order to fill its projected budget gap for the upcoming year; and

WHEREAS, one of the proposed measures is reducing the current 6 day a week service to 5 days a week; and

WHEREAS, postal employees have been rallying to inform the public about the actual financial situation at the U.S. Postal Service and what's at stake for residents and businesses; and

WHEREAS, the Postmaster General has recently stated that he believes the postal service could reduce to 4 day or even 3 day, which would result in making part time employees out of current full time positions; and

WHEREAS, the proposal to reduce operations to 5 days a week would save 3% of operating costs but would result in a 17% loss of service for Buffalo businesses and residents; and

WHEREAS, this reduction would eliminate 200 full time jobs in Buffalo.

NOW, THEREFORE, BE IT

RE: WNY Stormwater Coalition: Rainwater Harvesting Installation Project (COMM. 22E-8)

WHEREAS, New York State has recently updated the Stormwater Management Design Manual making the implementation of green infrastructure a priority; and

WHEREAS, the Western New York Stormwater Coalition has decided to lead by example by constructing five (5) stormwater cisterns to capture rainwater for reuse and to reduce the need for potable water in municipal operations (The "Rainwater Harvesting Installation Project" or "Project"); and

WHEREAS, the Erie County Department of Environment and Planning coordinates the activities of the Coalition; and

WHEREAS, the total estimated maximum cost of the Project is \$732,220; and

WHEREAS, the DEP has submitted a grant application on behalf of the WNYSC to the New York State Environmental Facilities Corporation (EFC) Green Innovation Grant Program (GIGP) for this Project and has been awarded \$626,000; and

WHEREAS, the terms of the grant award under the GIGP require the commitment of a minimum of 10% local match of in kind services; and

WHEREAS, the required in-kind match for this award, in the form of engineering and construction services, will be provided by the municipal partners the Town of Tonawanda, the Village of Orchard Park as well as by the Erie County Department of Public Works and the Erie County Department of Environment and Planning; and

WHEREAS, it is necessary to execute agreements with EFC and the Town of Tonawanda and the Village of Orchard Park to accept the grant award and implement the project; and

WHEREAS, the Department of Environment and Planning accepted lead agency status and conducted a coordinated State Environmental Quality Review Act (SEQR) review which did not reveal any significant environmental impacts from any of these projects.

NOW, THEREFORE, BE IT

RESOLVED, that the Department, on behalf of the Coalition, is authorized to participate in all aspects of the New York State Environmental Facilities Corporation's 2010 GIGP for the Project; and be it further

RESOLVED, that the County Executive is authorized to execute the necessary agreements with EFC, the Town of Tonawanda, and the Village of Orchard Park to execute the grant agreement, secure necessary commitments from our project partners as well as the authorization to coordinate and implement the installation of the proposed systems on the municipal partners sites; and be it further
