WHEREAS, recently, the conviction of Muzzammil Hassan of second degree murder reveals a glaring flaw in the current penal law; and

WHEREAS, a first degree murder conviction was not possible and not pursued, because the crime did not fit into any of the thirteen categories of first degree murder; and

WHEREAS, the facts of the present case demonstrate the need to include such a cold blooded, pre-meditated murder into the definition of murder in the first degree; and

WHEREAS, while murder in the first degree and murder in the second degree are both class A-1 felonies, the minimum sentence for conviction of each crime is different; and

WHEREAS, a first degree murder conviction brings a minimum sentence of twenty-five years in prison, pursuant to New York State Penal Law §70.00 and a maximum of life without parole; and

WHEREAS, a second degree murder conviction brings a minimum sentence of only fifteen years and a maximum of 25 years to life; and

WHEREAS, as such, creating a category of murder in the first degree to include cold blooded, pre-meditated murders with aggravating factors, such as excessive barbarism, would have the immediate effect of increasing the minimum sentence for such a murderer.

WHEREAS, in September 1973 nine western New York counties established, as enabled by New York State law, the Western Regional Off Track Betting Corporation, WROTBC; and

WHEREAS, the county stakeholders established an oversight board represented by each community for local control and authority to regulate and administer gaming in each participating county; and

WHEREAS, since 1973 eight additional counties have joined this regional corporation, funding it in its entirety as a seventeen member county organization; and

WHEREAS, any gains in asset growth or profit from operations have been the result of the oversight and management by the member counties and their representatives, and any losses in operations were not sustained by New York State or any other entity; and

WHEREAS, gains realized have been distributed to the contributing member counties for the benefit of all taxpayers who funded the Western Regional Off Track Betting Corporation as owners; and

WHEREAS, the current net equity in 2011 of approximately \$39 million in the assets, including the branch facilities and the racetrack and gaming casino in Batavia, NY therefore are the exclusive property of the funding counties on a pro rata basis; and

WHEREAS, Erie County has earned profit distributions from WROTBC in the years 1974 and 2009 of \$68,991,274; and

WHEREAS, New York State government has proposed the taking of WROTBC assets and local control authority by consolidation of all similar off track betting corporations with the WROTBC, which will dilute the authority of the WROTBC board and represent a taking of property developed by the WROTBC with substantial risk unto itself, and significant reinvested monies to insure the financial health and stability of the WROTBC; and

WHEREAS, the member counties of WROTBC including Erie County, oppose the consolidation or other measures that improperly divest the sustaining counties of WROTBC from their assets and control without appropriate recompense.

NOW, THEREFORE, BE IT

RESOLVED, that Erie County as a member of WROTBC, joins the other member counties in opposition to proposals unfair to the equity positions of the stakeholders by New York State or other entity; and be it further

WHEREAS, the State of New York, Department of Agriculture, has always imposed a three dollar surcharge to be added to the license fee for un-spayed and un-neutered dogs; and

WHEREAS, this three dollar surcharge, paid by owners of intact dogs, was then used to control dog populations by funding spay/neuter programs, thereby putting the cost of such programs on those who choose to keep their dogs intact; and

WHEREAS, responsible dog owners who have sterilized their dogs through spaying or neutering were therefore able to enjoy a reduced licensing fee, exempt from spay/neuter fees of any kind: and

WHEREAS, the State of New York, Department of Agriculture, as of January 1, 2011 has transferred dog licensing to the local government level, while maintaining the original three dollar spay and neuter fee, now called a spay/neuter surcharge; and

WHEREAS, the State of New York, Department of Agriculture, is now imposing a new spay and neuter surcharge of one dollar to be added to the license fee of each altered dog; and

WHEREAS, imposing a spay and neuter surcharge is a disincentive to maintaining a dog license, encouraging unlicensed dogs; and

WHEREAS, dog licensing, among other purposes, helps to control vector-borne diseases, such as rabies, by insuring that licensed dogs are vaccinated; and

WHEREAS, New York State has decreased funding for programs to prevent vector-borne diseases; and

WHEREAS, it is counterintuitive and a public health risk to disincentivise licensing dogs.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature opposes the imposition of a new spay/neuter surcharge meant for owners who have responsibly sterilized their dogs, thereby contributing to the control of the State of New York's dog population and vector-borne diseases; and be it further

RESOLVED, that a certified copy of this resolution be forwarded to Governor Andrew Cuomo, Senate Majority Leader Dean Skelos, Assembly Speaker Sheldon Silver and the local delegation to the New York State Legislature.

WHEREAS, wind energy is among the new technologies that shows promise to lead us to a clean energy future and we have an abundance of this unlimited resource in Erie County; and

WHEREAS, the proposal by the New York Power Authority (NYPA) to consider Lake Erie for its Great Lakes Off-Shore Wind (GLOW) project raises many questions about the safety of the project and the economic and environmental impact on Erie County residents; and

- the number of wind turbines and where exactly in the Lake they would be situated;
- what protections can be assured that potentially toxic sludge on the Lake Erie floor will not be disturbed;

- what impact will maintenance and repair times for off-shore turbines and towers have and what is the cost savings of locating the towers in the Great Lakes versus at an on-shore location, must be answered by the New York Power Authority before planning can move forward on this project.

WHEREAS, the installation of a wind farm could negatively impact shipping lanes used to transport goods on the Great Lakes; and

WHEREAS, the installation of a wind farm would tend to increase avian mortality among threatened species, an issue brought to light recently by individuals choosing a design for a new bridge to span the Niagara River; and

WHEREAS, shorts in electric cables could injure or kill aquatic wildlife; and

WHEREAS, wind farms have been shown to interfere with accurate weather predicting, which is an important consideration in a region subject to extreme weather patterns; and

WHEREAS, the low frequency sounds caused by wind farms could potentially be damaging to marine habitat; and

WHEREAS, the future of Buffalo and Erie County would be negatively impacted by the installation of a wind farm in Lake Erie.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature opposes the exploitation of Lake Erie as a site for a wind farm; and be it further
