Re: Public Notice Concerning Position of Erie County Director of Western Regional Off-Track Betting Corporation

Dear Clerk Graber:

Under New York Consolidated Laws, Racing, Pari-Mutuel Wagering and Breeding Law - PML § 502, the Erie County Legislature appoints one person to serve on the Board of the Western Regional Off-Track Betting Corporation (WROTB). Under the law, each director shall serve at the pleasure of the governing body appointing him/her and each director shall continue to serve until the appointment and qualification of his/her successor.

The Erie County Legislature will be acting to appoint a new director to serve on WROTB.

Accordingly, please take the necessary steps to provide proper public notice to interested parties who wish to apply for the position of Erie County Director of the Western Regional Off-Track Betting Corporation. This requires that notice be given to members of the Legislature, the news media and that the notice should be posted on the Erie County Legislature's website informing all interested parties to submit letters of interest, including a resume, not later than 5:00 pm on Thursday, March 26, 2020 to your attention.
