COUNTY OF ERIE LOCAL LAW INTRO. NO. 1 (PRINT #1) 1997

A LOCAL LAW amending section 1813 of Erie County Local Law Number 1 of 1959, as amended, constituting the Erie County Charter, with respect to membership of the Audit Committee for the County of Erie.

BE IT ENACTED BY THE LEGISLATURE OF ERIE COUNTY AS FOLLOWS:

Section 1. Subdivision A of Section eighteen hundred thirteen of Erie county local law number one of nineteen hundred fifty-nine, as amended, constituting the Erie county charter, is amended to read as follows:

A. There is hereby created and established an audit committee for the county of Erie consisting of the following five members appointed for the following terms:

a. One majority member of the county legislature to be appointed annually be the majority members of the legislature.

b. One minority member of the county legislature to be appointed annually by the minority members of the legislature. c. The county legislature shall consider at least three qualified candidates which have recommended by the Erie county bar association and shall initially appoint one of those nominees for a one year term. Thereafter, and at the expiration of the term of the initial appointee, the appointment shall be made for a term of three years.

d. The county legislature shall consider at least three qualified candidates which have been recommended by the western New York chapter of the New York state association of certified pubic accountants and shall initially appoint one of these nominees for a two year term. Thereafter, and at the expiration of the term of the initial appointee, the appointment shall be made for a term of three years.

e. The county legislature shall consider at least three qualified candidates which have been recommended by [the bank administrative institute and shall initially appoint one of these nominees for a three year term] <u>commercial banks located within Erie County,</u> and shall appoint one of such nominees to a three-year term. Should fewer than three such candidates be recommended by commercial banks, the legislature may add a resident of Erie County who has demonstrable expertise in commercial banking industry to the list of nominees. Thereafter, and at the expiration of the term of the initial appointee, the appointment shall be made for a term of three years. With th exception of the legislative members, no [No] appointee may serve for more than two <u>conservative</u> terms. Each appointee may be removed only for cause by the respective appointing authorities. Vacancies shall be filled by members appointed by whomever make the initial appointment. A member appointed to fill a vacancy shall serve for the duration of the [expired] <u>unexpired</u> term.

Section 2. This local law shallbe effective immediately.

WHEREAS, in order to maintain health-care inflation costs at a sustainable level, Managed Care costs have been controlled in HMO plans by limiting access to specialists, tests and other services, and

WHEREAS, while cost and efficiency are laudable goals, the ultimate decision about how patient care is to be managed should not compromise the quality of care he or she is receiving, and

WHEREAS, decisions such as the length of maternity stays and restrictive drug prescription plans are routinely made by HMO Planners without consideration of quality of life issues, requiring State and Federal legislation involvement, and

WHEREAS, the New York State Assembly and Senate recently passed legislation which helps to regulate the delivery of managed health care and make available to health care consumers more detailed coverage options, and bans certain limitations imposed by HMO's (A-11329 and S-7553), and

- Understand that the consolidation effort should result in governments spending less money, not more;
- Finally and most importantly, recognize that consolidation does not mean county grants, cost shifting or an Erie County takeover of city-run and city-specific programs and services. Consolidation must yield savings to all taxpayers and, hopefully, produce more efficient services for all county and municipal residents and taxpayers.

And be it further

RESOLVED, that a certified copy of this resolution be forwarded to the members of the County-Municipal Consolidation Committee, County Executive Gorski, Buffalo Mayor Masiello, and to the mayors and supervisors of all remaining city, town and village governments within Erie County.

WHEREAS, The Erie County Auto Bureau retained \$2.2 million and provided \$32 million for New York state in 1996, thus establishing itself as a highly profitable agency for the state, and

WHEREAS, Among the services provided by the Erie County Auto Bureau are the processing of mail-in drivers' license and registration renewals, a function which comprises 44 percent of Erie County terminal transactions and nearly 50 percent of county Department of Motor Vehicles revenue, and

WHEREAS, In the 1997-98 Executive Budget New York state Governor George Pataki proposes centralizing mail-in license and registration renewals, thus taking the function away from the Erie County Auto Bureau despite the fact that while the Erie County Auto Bureau can return mail in renewals in three to four days it will take the state 15 to 18 days, and

WHEREAS, The Erie County Auto Bureau will be expected to reduce costs through layoffs and/or branch closings if centralization of mail-in renewals is enacted, even though walk-in service will not be decreased; thus resulting in longer lines and less staff to service the Western New York community, and

WHEREAS, While Governor Pataki proposes increasing the county portion of gross receipts from 8.1 percent to 11 percent the actual amount of revenue the county agency will keep will actually be reduced due to the loss of mail-in renewal revenue,

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby reaffirm its commitment to ensuring the highest level of service for the Western New York community, and be it further

WHEREAS, Absent any coordinated effort to alter current transportation patterns, the quality of life for residents in the area of the proposed Northeast Buffalo Parkway would be negatively affected by the increase in noise and truck traffic on targeted residential streets, and

WHEREAS, The construction of Northeast Buffalo Parkway entrance and exit ramps on the Kensington Expressway (NY Route #33), would address residential concerns regarding pedestrian safety by re-routing traffic away from residential streets, neighborhood schools and playgrounds,

WHEREAS, The construction of said ramps would result in the relief of traffic congestion as well as necessitate the removal of the Kensington Avenue overpass which has been the site of several fatalities and a source of public safety concern, and replacing it with a four way, traffic signal controlled intersection

WHEREAS, With the closing of the Gowanda Psychiatric Center in the early 1990s due to cuts by then New York state Governor Mario Cuomo the Buffalo Psychiatric Center has assumed an even more important role in the treatment of the mentally ill population in Western New York, and

WHEREAS, Despite its obviously important and necessary function, Governor Pataki has somehow seen fit to nevertheless conduct a continued assault on the Buffalo Psychiatric Center, cutting over 650 beds in the last six years from the facility, leaving hundreds of patients so desperately in need of treatment with no place to go, and

WHEREAS, In the past year alone the Buffalo Psychiatric Center has lost over 200 staff members to transfer, resignation and retirement due to this continued assault on the institution, and

WHEREAS, Continued cuts threaten the very existence of the Buffalo Psychiatric Center, as the facility is targeted to be reduced to 250 beds by April 1, 1997; a figure called "the minimum necessary to be defensibly kept open" by professionals in the field,

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby reaffirm its commitment to ensuring all those in need of treatment for mental illness receive accessible, quality care, and be it further RESOLVED, That this Honorable Body does hereby commend the efforts and successes of the Buffalo Psychiatric Center for their constant high standards of care for the mentally ill, and be it further

RESOLVED, That this Honorable Body does hereby memorialize New York state Governor George Pataki to immediately cease cuts to the Buffalo Psychiatric Center for the good of the entire Western New York community, and be it further

RESOLVED, That this Honorable Body does hereby memorialize the New York state Legislature to restore any cuts proposed by Governor Pataki, and furthermore increase funding to the Buffalo Psychiatric Center so as to begin the process of bringing the Center's number of beds back up to past levels; levels sorely needed to properly treat the mentally ill population of the area, and be it further

WHEREAS, Therefore, police and firefighters who live in the community in which they work will have an even greater pride in that community and an even greater stake in the preservation and improvement of that community, and

WHEREAS, To that end virtually all of the suburban municipalities in Erie County require their police and firefighters to live in the town or village in which they work, and

WHEREAS, Those police and firefighters take great pride in their community and ensure its safety while on the job, as well as provide a stable middle class for the municipality, and

WHEREAS, Buffalo is currently unable to fully integrate its police and firefighters into the city through a residency provision due to convoluted and unjust state laws which prohibit municipalities whose police force numbers over 200 and municipalities with paid fire departments from requiring residency, and

WHEREAS, Due to the lack of a residency law for its police and firefighters, 40 percent of Buffalo's firefighters and 50.5 percent of its police currently live outside the city, and

WHEREAS, This state law for no sound reason places an unnecessary burden on the city of Buffalo and all its residents, and

WHEREAS, To remedy the current egregious situation, New York state Assemblymember Sam Hoyt has introduced legislation in the state Assembly which would allow the city of Buffalo the option of enacting a residency requirement for its police and firefighters if it so chooses, and

WHEREAS, A grandfather clause in the bill ensures no hardship for already-employed police or firefighters, as only new hires would be required to reside in Buffalo if the city chooses to enact residency requirements, and

WHEREAS, While the bill does not require the city of Buffalo to enact residency requirements, the current state laws prohibiting them must be overturned so as to allow Buffalo the opportunity to decide its own future course on this important issue, NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby reafirm its commitment to ensuring the strength of all the county's municipalities and the safety and well-being of all its citizens, and be it further

RESOLVED, That this Honorable Body does hereby support and endorse the ideals of choice and self-determination for all the county's municipalities in the guidance of those municipalities' workforces, and be it further
