WHEREAS, It has been reported that the Western New York area has lost upwards of 800 long-term psychiatric care beds in the last five years, and

WHEREAS, As a result, more mentally-ill patients who would greatly benefit from such care are forced to live in mostly unsupervised settings, with outpatient visits from mental health care workers, and

WHEREAS, Mental health care workers have reported that in some cases it is unsafe for them to make said visits, especially under the current system where they make these visits alone, and that they fear for their safety in some cases, and

WHEREAS, These worst fears were tragically realized recently when a mental health care worker on a visit was killed by the patient being visited, reportedly because the patient was distraught over a judicial decision concerning her inability to care for her child, and

WHEREAS, The Erie County Legislature does feel that action must be taken to insure the safety of mental health care workers during the performance of their duties,

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby voice its concern for the safety of mental health care workers in our community, and be it further

RESOLVED, That this Honorable Body does hereby request that Erie County Department of Mental Health Commissioner Ellen Grant Bishop appear at a future meeting of the Legislature's Health/Mental Health Committee to discuss how to improve services for mental health patients while also increasing the safety of mental health care workers, including but not limited to discussing the extent to which more long term psychiatric services are needed, the review of individual cases to determine possible violent behavior, and the possibility of mental health care workers performing site visits in pairs, and be it further

RESOLVED, That this Honorable Body does hereby request that Erie County Sheriff Patrick Gallivan appear at the same meeting of the Legislature's Health/Mental Health Committee to discuss the possibility of law enforcement escort or some other protective measures for mental health workers in cases where it has been determined that there is a possibility of violence, and be it further

RESOLVED, That certified copies of this resolution be forwarded to Erie County Department of Mental Health Commissioner Ellen Grant Bishop, Erie County Sheriff Patrick Gallivan, and Erie County Executive Dennis Gorski.

WHEREAS, It has been reported that AIDS is the number one cause of death among Americans 24-44 years of age, and

WHEREAS, Within Erie County, statistical data shows that AIDS cases have increased 84 percent; from 678 diagnosed cases as of July 31, 1995 to 1,245 diagnosed cases as of June 30, 1998, and

WHEREAS, Within this same time frame the number of African-Americans diagnosed with AIDS has increased 99 percent, and

WHEREAS, African-Americans account for 50 percent of all the diagnosed AIDS cases in the County of Erie, and

WHEREAS, Based on these startling facts it is evident that additional efforts must be undertaken to provide general health education and preventative information to stem the increase of AIDS in Erie County, especially in the African-American community, and

WHEREAS, Said educational effort must include information that will emphasize relationship skills and self-esteem workshops, and

WHEREAS, The Erie County Department of Health has been developing an outreach project that includes the aforementioned elements and that forges alliances with grassroots organizations that provide services within the African-American community,
