WHEREAS, The accounting firm of Deloitte & Touche LLP submitted the second lowest bid to the Audit Committee for the audit of the County's financial statements and Single Audit for fiscal years 1995 – 1998, and

WHEREAS, Due to the lateness of the request by KPMG Peat Marwick for an increase in their contract, the Audit Committee and the Comptroller are of the opinion that the release of a new RFP, evaluation of proposals and selection of a new auditor would significantly delay the 1998 audit, and

WHEREAS, revenues to support ECC's operating budget comes from three primary sources, including direct student tuition, state aid and the annual sponsor (county) contribution, and

WHEREAS, the ECC budget is an enrollment driven budget as approximately 70% of the college's operating revenues are influenced by student enrollment figures, including direct tuition revenues and state aid, which is calculated on a three years weighted average, and

WHEREAS, the sponsor (county) contribution for the 1997-98 ECC budget is \$11,474,777, or 17.8%, of the total ECC budget, representing the highest percentage of the total ECC budget, in terms of sponsor contribution, in five years, and

✓ WHEREAS, additionally, Erie County will contribute more than ~~X~~ \$2.5 million in capital debt service payments for ECC in 1998, and

WHEREAS, Over the past five years, Erie County has worked diligently toward increasing ECC's county contribution, in spite of the increasing demands state mandated programs have imposed on the operating budgets of urban counties in New York State, including Erie County, and

WHEREAS, As an urban county, Erie County has had to bear a disproportionately large share of the costs associated with these state mandated programs, while working concurrently to support a multi-campus community college, and

WHEREAS, Toward maintaining a quality and accessible community college system, Erie County and ECC are further challenged by the intense competition experienced in Western New York with sixteen other colleges and universities, and

WHEREAS, a special committee has been established to recommend college budget short and long-term revenue enhancements and cost reduction efficiencies, and

WHEREAS, Demographic trends, a relatively stagnant local economy and increased competition have all contributed to declining student enrollments over the past five years, thereby having an adverse influence on tuition and state aid revenues, and

WHEREAS, While increasing the level of state aid is helpful, currently \$1900 per Full Time Equivalent (FTE), representing 30.2% of the total budget, Erie County and the other urban county sponsors need additional assistance in order to maintain quality and accessible community college programming, and

WHEREAS, For 1997-98 college fiscal year, New York State could increase its level of aid to ECC by 9.8%, representing \$6,324,089, without exceeding the 40% total budget contribution, and

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby memorialize the New York State Legislature to draft and adopt the appropriate legislation which accomplishes the following two goals:

- * a certification made in accordance with a contract between the U.S. Secretary of the Interior, the State Commissioner of Parks, Recreation and Historic Preservation which authorizes the commissioner or the local government to certify the rehabilitation of the building, and

Legislature of Erie County, amending the Erie County Sales and Use Tax Resolution which imposes taxes on sales and uses of tangible personal property and on certain services, and on occupancy of hotel rooms, admission charges and club dues, pursuant to Article 29 of the Tax Law of the State of New York, to continue the imposition of the additional 1% rate of tax, pursuant to Chapter ~~1~~ of the Laws 1998.

Be it enacted by the Legislature of the County of Erie, as follows:

Section 1. The first sentence of section two of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie being Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

SECTION 2. Imposition of sales tax. On and after March first, nineteen hundred eighty-nine, there is hereby imposed and there shall be paid a tax of three percent upon, and for the period commencing March first, nineteen hundred eighty-nine, and ending February twenty-eighth, nineteen hundred [ninety-eight] ninety-nine, there is hereby imposed and there shall be paid an additional tax of one percent upon:

Section 2. Subdivisions (h) and (i) of section three of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie being Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, are hereby amended to read as follows:

(h) With respect to the additional tax of 1 percent imposed for the period commencing March 1, 1989, and ending February 28, [1998] 1999 the provisions of subdivisions (a), (b), (c), (d), (e), (f), and (g) of this section apply, except that for the purposes of this subdivision, all references in said subdivisions (a), (b), (d), and (e) to an effective date shall be read as referring to March 1, 1989, all references in said subdivision (a) to the date four months prior to the effective date shall be read as referring to November 1, 1988, and the reference in subdivision (b) to the date immediately preceding the effective date shall be read as referring to February 28, 1989.

Nothing herein shall be deemed to exempt from tax at the rate in effect prior to March 1, 1989, any transaction which may not be subject to the additional tax imposed effective on that date.

(i) The taxes imposed under subdivisions (a), (c) and (d) of Section 2 shall be paid at the rate of 3 percent upon all sales made and services rendered on or after March first, nineteen hundred [ninety-eight] ninety-nine. With respect to the tax rate of 3 percent effective March first, nineteen hundred [ninety-eight] ninety-nine, the provisions of subdivisions (b), (c), (d), (e) and (f) of this section apply, except that for purposes of this subdivision, all references in said subdivisions (b), (c), (d) and (e) to an effective date shall be read as referring to March first nineteen hundred [ninety-eight] ninety-nine, and the reference in subdivision (b) to the date immediately preceding the effective date shall be read as referring to February twenty-eight, nineteen hundred [ninety-eight] ninety-nine. Nothing herein shall be deemed to exempt from tax at the rate in effect prior to March first, nineteen hundred [ninety-eight] ninety-nine any transaction which may not be subject to the lowered tax rate in effect on that date.

Section 3. Section four of the Erie County Sales and Use Tax Resolution, being a resolution adopted by the Board of Supervisors of the County of Erie being Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended is amended to read as follows:

SECTION 4. Imposition of compensating use tax.

(a) Except to the extent that property or services have already been or will be subject to the sales tax under this resolution, there is hereby imposed on every person a use tax for the use within this taxing jurisdiction on and after March first, nineteen hundred eighty-nine, except as otherwise exempted under this enactment, (A) of any tangible personal property purchased at retail, (B) of any tangible personal property (other than computer software used by the author or other creator) manufactured, processed or assembled by the user, (i) if items of the same kind of tangible personal property are offered for sale by him in the regular course of business, or (ii) if items are used as such or incorporated into a structure, building or real property by a contractor, subcontractor or repairman in erecting structures or buildings, or building on, or otherwise adding to, altering, improving, maintaining, servicing or repairing real property, property or land, as the terms real property, property or land are defined in the real property tax law, if items of the same kind are not offered for sale as such by such contractor, subcontractor or repairman or other user in the regular course of business, (C) of any of the services described in paragraphs (1), (7), and (8) of subdivision (c) of section 2, (D) of any tangible personal property, however acquired, where not acquired for the purposes of resale, upon which any of the services described under paragraphs (2), (3) and (7) of subdivision (c) of section 2 have been performed, (E) of any telephone answering service described in subdivision (b) of section two, and (F) of any computer software written or otherwise created by the user if the user offers software of a similar kind for sale as such or as a component part of other property in the regular course of business.

(b) For purposes of clause (A) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after March first nineteen hundred [ninety-eight] ninety-nine, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for such property, or for the use of such property, including any charges for shipping or delivery as described in paragraph three of subdivision (b) of section one, but excluding any credit for tangible personal property accepted in part payment and intended for resale.

(c) For purposes of subclause (i) of clause (B) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after March first nineteen hundred [ninety-eight] ninety-nine, the tax shall be at the rate of three percent, of the price at which items of the same kind of tangible personal property are offered for sale by the user, and the mere storage, keeping, retention or withdrawal from storage of tangible personal property by the person who manufactured, processed or assembled such property shall not be deemed a taxable use by him.

(d) For purposes of subclause (ii) of clause (B) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after March first, nineteen hundred [ninety-eight], ninety-nine, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the tangible personal property manufactured, processed or assembled into the tangible personal property the use of which is subject to tax, including any charges for shipping or delivery as described in paragraph three of subdivision (b) of section one.

(e) Notwithstanding the foregoing provisions of this section, for purposes of clause (B) of subdivision (a) of this section, there shall be no tax on any portion of such price which represents the value added by the user to tangible personal property which he fabricates and installs to the specifications of an addition or capital improvement to real property, property or land, as the terms real property, property or land are defined in the real property tax law, over and above the prevailing normal purchase price prior to such fabrication of such tangible personal property which a manufacturer, producer or assembler would charge an unrelated contractor who similarly fabricated and installed such tangible personal property to the specifications of an addition or capital improvement to such real property, property or land.

(f) For purposes of clauses (C), (D) and (E) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after March first, nineteen hundred [ninety-eight] ninety-nine, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the service, including the consideration for any tangible personal property transferred in conjunction with the performance of the service and also including any charges for shipping and delivery of the property so transferred and of the tangible personal property upon which the service was performed as such charges are described in paragraph three of subdivision (b) of section one.

(g) For purposes of clause (F) of subdivision (a) of this section, the tax shall be at the rate of four percent, and on and after March first, nineteen hundred [ninety-eight], ninety-nine, the tax shall be at the rate of three percent, of the consideration given or contracted to be given for the tangible personal property which constitutes the blank medium, such as disks or tapes, used in conjunction with the software, or for the use of such property, and the mere storage, keeping, retention or withdrawal from storage of computer software described in such clause (F) by its author or creator shall not be deemed a taxable use by such person.

Section 4. Subdivision (D) of clause (1) of Section 11 of the Erie County Sales and Use Tax Resolution, being resolution adopted by the Board of Supervisors of the County of Erie being Item 8 of Meeting Number 31, held July 27, 1965, Supervisors Proceedings, page 666, as amended, is amended to read as follows:

(D) With respect to the additional tax of one percent imposed effective for the period beginning March first, nineteen hundred eighty-nine, and ending February twenty-eight, nineteen hundred [ninety-eight] ninety-nine, in respect to the use of property used by the purchaser in this County prior to March first, nineteen hundred eighty-nine.

Section 5. This enactment shall take effect March first, nineteen hundred ninety-eight.


