WHEREAS, it is a moral imperative that Erie County government put to use all budgeted resources to combat child abuse and, therefore, should first look to itself to determine if every effort is being made on a county level to address the issue of child abuse, and

WHEREAS, the office of the Erie County Comptroller has informed this Honorable Body that nine vacancies exist in the Child Protection Registry and Child Protection Services within the Erie County Department of Social Services, and

WHEREAS, the nine vacant positions include: (2) Senior Child Protection Workers, (2) Child Protection Workers-Spanish Speaking, (4) Child Protection Workers and (1) Senior Clerk Typist, and

NOW, THEREFORE, BE IT

RESOLVED, that this Honorable Body requests County Budget Director Kenneth Kruly and Social Services Commissioner Deborah Merrifield to appear before the next meeting of the Social Services Committee to provide the Legislature with information pertaining to the length of time these positions have been vacant and the reasons for the vacancies, and be it further

WHEREAS, the use of welfare benefits in illegal activities threatens the integrity of our social services system, diverts resources from the truly needy and denies the taxpayers of this state and county the services for which their tax dollars are being levied.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby express its concern that taxpayer dollars are at times used to subsidize the illegal activities of welfare recipients, and be it further

RESOLVED, that this Honorable Body does hereby request Erie County Department of Social Services Commissioner Deborah Merrifield and Erie County Sheriff Patrick Gallivan to appear at a future meeting of the Legislature's Social Services Committee to discuss the possible remedies to the aforementioned situation including removing from the welfare rolls individuals convicted of using their benefits in an illegal manner or having their benefits associated with illegal activities, as well as ways to ensure the safety and well-being of family members who rely on the benefits of those convicted of illegal activities, and be it further

WHEREAS, according to the National Committee to Prevent Child Abuse, three children die in our nation every day as a result of maltreatment, and

WHEREAS, confidentiality laws in New York State have proven to be dangerous to children who may be protected if information held by Departments of Social Services could be more readily shared, and

WHEREAS, there has been a numerous incidents across Erie County and New York State that have emphasized the fact that the Social Services system, due in part to the confidentiality laws that have become the benchmark of Social Services, is destined to fail those who it is supposed to protect, and

WHEREAS, in 1992, resolution Intro. 6-2 was submitted to the Erie County Legislature by members of the Republican Minority who supported changes to the confidentiality laws with respect to social services, and

WHEREAS, the resolution noted various cases of tragedy such as a case in New York City in which a mother beat her 8 year old son so badly that he was in a coma, and

WHEREAS, a court placed the mother on five years of probation, only to return her three sons, including the one she had beaten, and

WHEREAS, shortly thereafter, one of the boys school teachers noticed signs of abuse and called the state child abuse line to report the incident, and

WHEREAS, a child abuse investigator assigned to the case was "shocked" by the condition of the child, and

WHEREAS, on the same day that the investigator first saw the child, arrangements were being made in family court to approve a final return home for the children and permissions to end the department's supervision over the family, and

WHEREAS, during March of 1990, the Probation Department moved to end its supervision over the mother, a year and a half before the probation was up, and

WHEREAS, before moving to end the supervision, the mother's probation officer sought information from the human resource

department but was denied access due to confidentiality laws, and

WHEREAS, by October of 1990, the abused child had been murdered by his mother, and

WHEREAS, this case clearly accentuates the need to amend the New York State Confidentiality laws, and

WHEREAS, another case sighted in the 1992 resolution Intro. 6-2 dealt with a foster mother charged with murder for beating her 6 year old niece, immersing her in a tub of cold water and taping her mouth shut, and

WHEREAS, police faced major obstacles in trying to piece the incident together because welfare authorities refrained from sharing information due to New York State Confidentiality laws, and

WHEREAS, in a 1992 case in the City of Buffalo, a woman cut the throats and drowned her two daughters and severely injured her son with a pick axe, and

WHEREAS, Ms. James' instability was well documented by the Erie County Department of Social Services yet none of this information had been forwarded to the police who could have checked in on this family from time to time and perhaps prevented this tragedy, and

WHEREAS, in another tragic case, Elisa Izquierdo, a Brooklyn girl, was murdered by her mother despite the fact that the New York City Department of Social Services was aware of abuse taking place in this home, and

WHEREAS, once again, due to confidentiality laws, police agencies and the District Attorney's office were left in the dark about this abuse until the unfortunate murder took place, and

WHEREAS, this case was the basis of 1996 resolution Intro.2-22 which called for the county to support "Elisa's Law", legislation that had been proposed by New York State Attorney General Dennis Vacco, and

WHEREAS, this law, will allow certain information to be shared

yet Attorney General Vacco has indicated that the law could, and should, go further to allow for division of information in a case where a child's life or well being is at risk, and

WHEREAS, the Republican Minority also sponsored legislation to allow disclosure of information when a convicted child molester has migrated to a particular neighborhood, and

WHEREAS, this law was also approved in New York State and has been called "Megan's Law" named after a young girl who had been raped and murdered by a convicted child molester, and

WHEREAS, just two months ago, two children died in a fire allegedly caused by their mother despite the fact that Department of Social Services had been notified by family and concerned neighbors that there were serious problems with the home environment, and

WHEREAS, an Erie County Surrogate Court Judge admonished the Department of Social Services calling one particular situation in which 10 children were sharing bed space in a two room apartment "a tragedy waiting to happen", and

WHEREAS, in this particular instance, the caretakers of these children were receiving more that \$33,000 per year from Social Services, yet the children were still living in horrendous conditions, and

WHEREAS, in hearing that this family was attempting to buy a home with the funds provided by Social Services, the judge questioned how this family could not afford to provide beds for their children yet they could afford a home, and

WHEREAS, a recent case in the City of Buffalo further highlights the need to share information with police and lawmakers as a young child had been living in squalor for months despite the fact that social workers had been made aware of the problem by school officials, and

WHEREAS, School 53 officials have made it quite clear that they feel as though either the Erie County Department of Social Services or state confidentiality laws or both have tragically failed this particular student, and

WHEREAS, all of the cases cited indicate that there is a need to address the burden that New York State confidentiality laws place upon police agencies, prosecutors, lawmakers, and child protectors who would be better able to conduct the business of saving the lives of children and the money of taxpayers of they are well informed when a child or welfare program is being abused,

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature is in support of the new laws created by state government such as "Elisa's Law" and "Megan's Law" and is committed to the full enforcement of such laws,

and be it further

RESOLVED, that this Legislative Body commends New York State Attorney General Dennis Vacco for his commitment to changing the laws that hamper those responsible for protecting children, and be it further

RESOLVED, that this Honorable Body agrees that more needs to be done to facilitate freer flow of information from the various local Departments of Social Services, and be it further

RESOLVED, that Erie County Department of Social Services Commissioner Deborah Merrifield and a representative from the New York State Attorney General's Office appear at a future meeting of the Legislature's Social Services Committee to discuss the impact of New York State confidentiality laws on the sharing of information between local departments of social services and law enforcement agencies, as well as the potential benefits and drawbacks of changing these laws, and be it further

RESOLVED, that this Legislative Body finds that the deaths of children due to abuse, neglect and maltreatment despite the involvement of government agencies charged with protecting these children is intolerable and unacceptable, and finds equally unacceptable laws which bar legitimate and appropriate inquiries about the activities of such agencies in these cases, for they

Screening for Children (Int. 7-

2)

WHEREAS, a recently released state Health Department report stated that Erie County children are testing positive for dangerously high lead levels at more than twice the statewide average, and

WHEREAS, the Health Department report stated that ideally children should have a zero lead blood level, however, health officials generally consider levels under 10 micrograms per deciliter acceptable, and

WHEREAS, when all categories of lead exposure were included, 6.8% of children in Erie County, younger than six years old in 1996, had lead levels above 10 micrograms, compared with a statewide rate of 4.2%, and

WHEREAS, while lead-based paint was banned from use in residential buildings more than twenty years ago, the aforementioned report states that the high number of older homes in Erie County, particularly in the City of Buffalo, many of which contain lead-based paint, is an important factor leading to the higher lead levels found in children, and

WHEREAS, inhaling or swallowing even small amounts of lead can result in health and developmental including brain damage and learning disabilities, and

WHEREAS, according to published reports, a 1992 state law requiring lead screening for children has not been enforced since its enactment, and

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature does hereby memorialize the New York State Legislature to appropriate funding for enforcement of the state law requiring lead screening for children, and be it further

RESOLVED, that this Honorable Body does hereby urge the state and county Health Commissioners to develop policy for the timely enforcement of the state law requiring lead screening for children, including the fiscal impact to both Erie County and New York State, in enforcing the aforementioned state law, and be it further

WHEREAS, Federal courts have already ordered nine states - Alaska, Arizona, parts of California, Delaware, Georgia, New Mexico, Oregon, Pennsylvania, and West Virginia Beach, to establish pollution limits, and

WHEREAS, The suits are based upon the 1972 clean Water Act, which requires states to force industries to use certain

technologies that keep from fouling water at specific discharge points, and

WHEREAS, That provision had been widely disregarded, and

WHEREAS, The Courts have imposed strict detailed clean-up schedules in Georgia, and

WHEREAS, the ruling has held economic development hostage until Georgia corrects its longstanding violations, and

WHEREAS, Plaintiffs are making increasingly stiff demands on states like New York, which has already agreed with the EPA to set limits around the upstate reservoirs that feed New York City's water supplies, and

WHEREAS, The natural Resources Defense Council is asserting that these agreements do not satisfy the full demands of the law, and

WHEREAS, Erie County is home to many fine watersheds and a variety of polluted sites.

WHEREAS, healthcare services received at these clinics are provided at no cost to students, however appropriate reimbursements are sought from Medicaid and other third-party payers, and

WHEREAS, school-based health clinics are supported with State funds administered by the State Departments of Health and Education, the Office of Mental Health, and financial support is also offered through the Robert Woods Johnson

Foundation, and

WHEREAS, despite the growing demand for school-based health programs, State funding has not increased for at least three years, and

WHEREAS, State Senator Velmanette Montgomery has suggested implementing a new funding stream of \$15 million to be established to offer additional support to School-Based Health Centers, and

WHEREAS, under Senator Montgomery's plan, \$6 million in new federal dollars appropriated for Child Health Plus would be matched by a \$6 million contribution from Managed Care organizations participating in Medicaid Managed Care, and \$3 million from Child Health Plus insurance plans, and

WHEREAS, this combined \$15 million would directly reimburse for school-based health services provided to their covered children and funds could be allocated according to a formula for funding new sites based on Medicaid and Child Health Plus enrollment, and

WHEREAS, Governor Pataki has proposed a plan to guarantee health insurance for every young New Yorker, and

WHEREAS, expansion of the Governor's proposal to include expansion of school-based health clinics would not only provide children with a mechanism to access health care but would also focus on easy access to health service in a supportive daily environment, and

WHEREAS, Since the 1970's Erie County has funded the school nurse program in the City of Buffalo, thereby demonstrating its support and commitment to school-based health care,

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature does hereby support increased State funding for school-based health clinics and Senator Montgomery's proposal to implement a new funding stream to support these programs, and be it further

WHEREAS, A recent FBI crime report shows that 30% of all murdered women are killed husbands or boyfriends who have know to have stalked them, and

WHEREAS, In 1992 the State Legislature took an important step toward recognizing that stalking requires stronger measures by amending New York menacing and harassment sections to include stalking behavior within the definitions of those crimes however, this step does not go far enough to protect the stalking victim, many of which are in life threatening danger, and

WHEREAS, State Legislators have proposed Bill A.1259 which would create a new and separate crime of stalking and add stiffer penalties to the crime than were previously imposed for the crimes of menacing and harassing, and

WHEREAS, This Bill establishes the crimes of stalking in the first, second and third degrees, it includes a provision that commission of the crime of stalking while in violation of a temporary or regular order of protection constitutes a felony, it gives the criminal and family courts concurrent jurisdiction over crimes of stalking, and specifically defines elements of the crimes of stalking,

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby support Assembly Bill A1259 for the greater protection it could bring to those being stalked by a known or unknown assailant, and be it further

WHEREAS, according to the Canadian Consulate General in Buffalo, the Government of Canada fully supports the LaFalce and Senator Abraham amendments, and

WHEREAS, D'Youville College currently enrolls approximately 350 Canadian citizens who travel from Ontario to Buffalo for classes, and has entered into an agreement with Seneca College in Toronto for an International Business Program which promises to bring more international students to D'Youville through Canada, and
