## **SUMMARY**

This resolution seeks approval to establish the Director of Real Estate position in the 2011 Budget.

### FISCAL IMPLICATIONS

Available funds in the Department of Public Works budget in the amount of \$129,453 will provide funding for this position in the 2011 Budget.

#### REASONS FOR RECOMMENDATION

Since the creation of this position the County has saved more than \$4.3 million dollars. The continuance of this position will allow for the continued analysis of utilizing industry standard methods of increasing efficiencies and thereby reducing the cost to the taxpayer. On average, the creation of the position has saved the county more than \$1.4 million annually. This position will continue to manage the County's real estate in the most efficient and cost effective method and identify additional ways to reduce the costs associated with said management.

In addition, the Director of Real Estate oversees all capital projects. Over the past three years this included the transfer of the Department of Motor Vehicles and County Attorney to the Rath Building - under budget and on time. This same position oversaw the renovating of the Convention Center and demolition of buildings at ECMCC – under budget and on time.

# BACKGROUND INFORMATION

This position was created in 2008 and has identified more than \$4.3 million dollars in savings and will continue to incorporate future industry standard practices to create additional management efficiencies.

# **CONSEQUENCES OF NEGATIVE ACTION**

The management of all County capital projects, lease administration and facilities management operational efficiencies will be negatively impacted. In particular, important capital projects at ECC will be significantly delayed if this position is not established. Future potential new efficiency savings will be eliminated.

# **STEPS FOLLOWING APPROVAL**

One Director of Real Estate position responsible for performing these functions will be created in the Department of Public Works, Division of Buildings and Grounds (REAM), pending the approval of the Commissioner of Personnel, the Director of Budget and the County Executive. The Director of Budget and Management will make necessary budgetary entries to balance the Utility Fund.

WHEREAS, Erie County instituted a Real Estate initiative in 2008 to review the way in which Erie County manages its owned and leased buildings; and

WHEREAS, this position facilitates all real estate capital projects, lease administration and facilities management in order to incorporate industry standard practices into County government; and

WHEREAS, this position resulted in more than \$4.3 million dollars of savings since it was created in 2008 and will continue to incorporate efficiencies into the overall management and construction of county owned and leased buildings to create additional savings; and

WHEREAS, funding for this position is available within the 2011 Department of Public Works Budget.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature hereby provides authorization to include one Director of Real Estate, JG 22, in the Department of Public Works effective January 1, 2011, and be it further

RESOLVED, that authorization is hereby provided to the Director of Budget and Management to make the following adjustments to the 2011 Budget in order to establish said position in the Department of Public Works, Division of Buildings and Grounds (REAM):
