Honorable Members:

Traditionally, the Department of Social Services has handled their own mail services. Now that the Department of Public Works is responsible for mail services for all County departments, there is one mail system for the entire County. Over the last year, much work has gone into improving the system of outgoing mail including the solicitation for one vendor to perform that service for the entire County. With that contract in place and the purchase of a new mail machine, DPW is now purchasing all postage for the County.

Currently there is a separate budgeted amount for postage in DSS and a separate budgeted amount in Public Works. In order for Public Works to now pay for all postage, this resolution seeks approval to move DSS funds budgeted for postage to DPW.

MEMORANDUM

SUMMARY

This resolution would transfer funds budgeted for postage in the Department of Social Services to the postage account in the Department of Public Works budget.

FISCAL IMPLICATIONS

There are no fiscal implications of the resolution. It will transfer existing funding from the Department of Social Services to the Department of Public Works.

REASONS FOR RECOMMENDATION

Instead of separating postage charges between two departments, all postage funding will be consolidated into the department that oversees all mail services. This will streamline the current postage purchasing practice and increase efficiency in the system.

BACKGROUND INFORMATION

Traditionally, the Department of Social Services handled their own mail services. Now that the Department of Public Works is responsible for mail services for all County departments, there will be one mail system for the entire County. Over the last year, much work has gone into improving the system of outgoing mail including the solicitation for one vendor to perform that service for the entire County. With that contract in place and the purchase of a new mail machine, DPW is now purchasing all postage for the County.

CONSEQUENCES OF NEGATIVE ACTION

The purchasing of postage will not be streamlined and the process will remain inefficient.

STEPS FOLLOWING APPROVAL

The Division of Budget will transfer the postage funds in DSS to DPW.
