DNA Laboratory Backlog Reduction Grant

The attached resolution requests authorization to enter into a contract with the Federal National Institute of Justice to accept grant funding in the amount of \$526,201 and to establish a new position of Forensic Biologist II.

This project will enable the Central Police Services Forensic Laboratory to perform forensic DNA analysis on up to 526 additional burglary and violent crime cases. It will allow the laboratory to more effectively process an increasing workload and reduce the number of DNA cases awaiting analysis. The implementation of this funding will enable the CPS Laboratory to continue to pursue their goal of providing the highest quality of service while continuing to improve the turn-around time associated with service delivery.

SUMMARY

The attached resolution requests authorization to enter into contract with the Federal National Institute of Justice (NIJ) to accept new grant funding in the amount of \$526,201. The resolution also requests authorization to establish a new position of Forensic Biologist II.

FISCAL IMPLICATIONS

There will be no impact on County funds. The grant is 100% funded by NIJ and will replace the grant established in the 2011 Budget, Book B.

REASONS FOR RECOMENDATION

The Erie County CPS Forensic Laboratory has a substantial backlog of DNA related cases in need of analysis. This initiative is intended to reduce this backlog and to enhance the capacity of the laboratory to promptly analyze items of evidence submitted from these types of investigations.

BACKGROUND INFORMATION

The Erie County CPS Forensic Lab has been processing a number of unsolved cases to determine if biological material can be recovered and typed using forensic DNA technology. We have obtained DNA profiles from a portion of these cases that have resulted in the successful prosecution and conviction of the identified individuals. This success has resulted in a steady increase in the number of cases submitted for DNA analysis, resulting in an increasing backlog. In order to further increase the analytical capabilities of the DNA Section, it is necessary to hire an additional Forensic Biologist II and to perform a portion of the lab work using overtime. The grant as approved in the 2011 Book B has already established an RPT Forensic Serologist position. These positions will result in the completion of up to 526 additional cases, including many property crimes such as burglary. Additional funding will be used to purchase laboratory equipment, maintenance and supplies required for DNA analysis.

CONSEQUENCES OF NEGATIVE ACTION

Failure to approve this request would restrict the CPS Forensic Laboratory in its efforts to reduce the number of backlogged cases awaiting DNA analysis and to enhance the operational capacity of its DNA Section.

STEPS FOLLOWING APPROVAL

Central Police Services will work with the Division of Budget and Management to implement this request.
