#### **SUMMARY**

Erie County currently contracts with Globalquest Solutions, Inc. for SAP consulting services to assist with the HR/Payroll Module and the FICO Module. At the time the 2011 budget was developed the assumption was that some of the consulting services would be handled by the transfer of a consultant to a County position. That transfer has not taken place and it is necessary to identify funding to continue the consultant relationship.

#### **FISCAL IMPLICATIONS**

Funds are available for transfer within DISS's 2011 Budget through the deletion of two (2) vacant positions.

#### **REASONS FOR RECOMMENDATION**

The SAP HR/Payroll for Eric County requires three payroll areas, over 700 work schedule rules, 8 bargaining units, an enterprise integrated time and attendance swipe system, and employee-managed self-service for time recording and benefit management. Additionally the County is deploying a Learning Management System utilizing SAP/Employee Self-Service, which is fully integrated with each employee's electronic personnel file. Due to this complexity an SAP experienced HR/payroll configurator with extensive government functional background is required. Our current contractor meets or exceeds these requirements.

#### **CONSEQUENCES OF NEGATIVE ACTION**

Due to the complexity that is cited above, the ability to manage changes as a result of bargaining unit changes, new contracts, will be very difficult, and may not be able to be fully implemented in a timely fashion. These operating goals may become difficult to achieve without contractor's experience.

### STEPS FOLLOWING APPROVAL

Adjustments will be made to DISS's 2011 Budget and payments will be made in accordance with the current agreement with Globalquest Solutions, Inc.
