### **SUMMARY**

Authorization to execute amended license agreement between CSX Transportation, Inc. and the County of Erie for Erie County Sewer District No. 6 is requested.

### **FISCAL IMPLICATIONS**

This contract does not impact on the County's General Fund. Costs related to the agreement will be paid from the Erie County Sewer District No. 6 - 2011 Adopted Budget.

### **REASONS FOR RECOMMENDATION**

The amended agreement will provide for a one time final payment versus making payments on an annual basis, thus reducing annual administrative costs and long-term costs.

### **BACKGROUND INFORMATION**

In 1984 Erie County, took over the sanitary sewer system of the City of Lackawanna. The existing license agreement with CSX Transportation, Inc., as it is a requirement prior to the installation of Sanitary Sewers on railroad properties, were assigned to the County. This agreement requires an annual lease payment. The Department of Environment and Planning, Division of Sewerage Management has negotiated a one time final payment to eliminate future annual billings.

### **CONSEQUENCES OF NEGATIVE ACTION**

The agreement will continue to require future annual payments as in the past.

### **STEPS TO FOLLOW APPROVAL**

Erie County will prepare and the County Executive will execute the amended agreement and the Comptroller's Office will make a final payment to the CSX Transportation, Inc.

WHEREAS, the County of Erie currently pays the license agreement fees on an annual basis; and

WHEREAS, the County of Erie and CSX Transportation, Inc. have negotiated a one time lump sum final payment; and

WHEREAS, the County of Erie and CSX Transportation, Inc. will amend the license agreement and the County will make a final payment of \$8,000.00; and

WHEREAS, \$8,000.00 is allocated in the Professional Services Account, Commitment Item 516020, of Erie County Sewer District No. 6 operating budget (1861010) in the 2011 adopted budget.

NOW, THEREFORE, BE IT

RESOLVED, that amended license agreement between the County of Erie and CSX Transportation, Inc., on behalf of Erie County Sewer Districts No.6 in the amount of \$8,000.00 is hereby approved; and be it further

RESOLVED, that the County Executive be, and hereby is authorized to execute the amended license agreement with the CSX Transportation, Inc. subject to approval as to form by the County Attorney and as to content by the Commissioner of the Department of Environment and Planning; and be it further
