Each season, Alleyway Theatre presents the work of dozens of actors, directors, designers, musicians, playwrights, and theatre technicians. The company also maintains an exhibit gallery where local visual artists show their paintings and photography. KidShowCo, our Children's theatre company, performs and presents educational workshops in area schools. Our annual Maxim Mazumdar New Play Competition helps inspire playwrights from around the world to pursue their craft with the knowledge that each year the best plays submitted will have their world premieres at Alleyway Theatre.
