To Whom It May Concern:

I, Michael LiVecchi, am writing to notify you of a property damage claim I would like to submit regarding 5390 Old Lakeshore Road, Lake View, NY 14085.

On Tuesday, November 15, 2011 at approximately 6:00pm, during a severe thunderstorm, my basement began to flood with sewage and water. I contacted the emergency department of the Erie County Sewer Authority who took note of the complaint and said he would send someone out to help. I then spoke with a representative from the Erie County Sewer Authority who stated that they had been here all week trying to rectify a sewer line problem that was inherited from Wanakah Sewer Authority that involved various lines throughout the neighborhood. The representative from Erie County gave me a number to call to report the problem and log an official complaint/claim.

At approximately 8:00pm another sewer authority representative arrived to turn on a sewer pump located on the opposite side of Old Lake Shore Road to stop the influx of sewer water into my basement. By this time, the water had risen to approximately 2 feet, damaging the majority of the items in the basement. A detailed listing and photo log of the items is attached.

I estimate the total value of the damaged items to be \$13,200.24

As instructed by the Erie County Sewer Authority, I am submitting this letter and items/photos of reference as my official claim. As many of the items damaged are things we use on a daily basis, I hope to get this rectified in a timely manner.
