MEMORANDUM

SUMMARY

Request adoption of a resolution to authorize the County Executive to award and enter into a contract with the responsible low bidder for the Bridge Painting Project once bids are taken and the lowest responsible bidder is determined; establish a construction contingency; and execute a change order with project engineers LiRo Engineers for construction inspection and services during construction.

FISCAL IMPLICATIONS

The total cost for the construction phase of this project is currently estimated at \$970,000, and is available in B.21011 - 2010 Bridge Painting Construction. The project is under an Agreement with the NYSDOT Locally Administered Federal Aid Program and is eligible for 80% reimbursement.

REASONS FOR RECOMMENDATION

Timely award of the contract is necessary so that the contractor can begin painting as soon as weather permits. The project benefits from Federal funds through the Locally Administrated Federal Aid Program.

BACKGROUND INFORMATION

This project is approved by the New York State Department of Transportation in their current Capital Program 5-year Plan to be funded through the Locally Administered Federal Aid Program. In order not to delay the project, it is recommended the County Executive be authorized to execute a contract with the responsible low bidder, establish the construction contingency, and execute a change order with project engineers LiRo Engineers once bids are taken and analyzed. This is the second Federal Aid Bridge Painting Project.

CONSEQUENCES OF NEGATIVE ACTION

The construction phase of the project will not be implemented in a timely manner and therefore, not completed. As a result, bridge painting will not start and Federal Aid for the project could be lost. Negative action would halt project advancement, expose the county traveler to health and safety risks because of bridge deterioration, and jeopardize existing and future reimbursement funding through this program.


STEPS FOLLOWING APPROVAL

The lowest responsible bidder will be determined by the Department of Public Works and a contract will be awarded. The County Executive will execute the construction contract, establish a construction contingency, and execute the negotiated change order with project engineers LiRo Engineers. Painting will begin as soon as possible depending on the weather. The Department of Public Works will notify the Legislature, for information only, the bid results and contract awardee.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

WHEREAS, the Bridge Painting Project PIN 5759.60 will be advertised, bid, and ready for award of construction contract to the responsible low bidder; and

WHEREAS, the Bridge Painting Project PIN 5759.60 will improve the condition of County bridges; and

WHEREAS, funding for this project was approved and is available in B.21011 - 2010 Bridge Painting Construction in the amount of \$970,000; and

WHEREAS, it is necessary that this approval be granted, so that the contract can be awarded to allow the contractor to begin painting as soon as possible; and

WHEREAS, in order to facilitate the Bridge Painting Project it will be necessary for the County to execute the construction contract with the responsible low bidder and establish a construction contingency; and

WHEREAS, a change order must be negotiated with LiRo Engineers, of Buffalo, New York, for construction inspection and services during construction. This is the second Federal Aid Bridge Painting Project.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive be authorized and is hereby directed to award and execute a contract for the Bridge Painting Project PIN 5759.60 between the County of Erie and the lowest responsible bidder, establish a construction contingency and execute a negotiated change order between the County of Erie and project engineers LiRo Engineers of Buffalo, New York; and be it further

RESOLVED, that funding for the Bridge Painting Project Two be allocated from fund B.21011 in an amount not to exceed \$970,000; and be it further

RESOLVED, that the County Executive of the County of Erie is hereby authorized to execute all necessary agreements, certifications or reimbursement requests for Federal Aid on behalf of the County of Erie with the New York State Department of Transportation in connection with the advancement or approval of the project; and be it further

RESOLVED, that the Department of Public Works will inform the Erie County Legislature, for information only, as to what contractor was the successful low responsible bidder for the Bridge Painting Project Two PIN 5759.60; and be it further

RESOLVED, that the Clerk of the Legislature be instructed to forward five (5) certified copies of this resolution to the Department of Public Works, Office of the Commissioner, and one copy each to the Office of the County Executive, the Division of Budget and Management, and the Office of the Comptroller.
