MEMORANDUM

SUMMARY

The Senior Services Department applied for and was awarded \$2,200 in funding from the National Senior Corps Association to conduct "Diabetes 101" classes as part of RSVP's University Express lifelong learning program.

FISCAL IMPLICATIONS

No additional County funds are required.

REASONS FOR RECOMMENDATION

The funding will be used to offer free educational sessions given by volunteer instructors on medical and nutritional aspects of diabetes, and free screening benefits through Medicare at eight senior centers/residences through RSVP's University Express lifelong learning program. The goal is to improve the health and well being of Erie County's seniors, age 65 and older, through encouraging use of the free, yet underutilized, preventive diabetes screening benefits that exist in Medicare. Early diagnosis is critical to avoid complications such as stroke, heart attack, vision loss or amputations. Screening Medicare beneficiaries with prediabetes is essential to help them take the necessary steps to prevent diabetes.

BACKGROUND INFORMATION

According to the Medicare Diabetes Screening Project, 10.9 million Americans age 65 and older have diabetes, and 3 million of those age 65 and older who have diabetes are undiagnosed. 14 million Americans have prediabetes with the vast majority undiagnosed. Medicare recipients who have diabetes account for 34% of Medicare spending. Screening and early detection are essential to prevent complications for people with diabetes and for prevention of the onset of the disease for those with pre-diabetes. Medicare now covers free annual screening for beneficiaries at-risk for diabetes. However, data from the Centers for Medicare and Medicaid Services (CMS) suggests that these benefits are underutilized, with only 10 - 12% of beneficiaries screened.

CONSEQUENCES OF NEGATIVE ACTION

Funding will not be available to conduct the "Diabetes 101" classes

STEPS FOLLOWING APPROVAL

The Department will process the budget revisions and conduct the "Diabetes 101" classes.

WHEREAS, the 2012 Erie County Budget includes funds appropriated for the 163RSVP1213 grant, for the period July 1, 2012 to June 30,2013; and

WHEREAS, the grantor has changed the 163RSVP1213 grant year to the period April 1, 2012 to March 21, 2013; and

WHEREAS, the Department applied for and was awarded \$2,200 in funding from the National Senior Corps Association to conduct "Diabetes 101" classes as part of RSVP's University Express lifelong learning program; and

WHEREAS, the "Diabetes 101" classes, to be held at various sites during the spring and fall of 2012, will provide Erie County seniors with information about symptoms, risks, and management of diabetes, the importance of early screening to prevent complications, and the availability of the free diabetes screening benefit through Medicare;

WHEREAS, the 163RSVP1213 grant budget is in need of revision.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive be and hereby is authorized to accept the \$2,200 award from the National Senior Corps Association to fund the RSVP's "Diabetes 101" classes, and be it further

RESOLVED, that 163RSVP1213 grant be for the period April 1, 2012 to March 31, 2013 and the budget for the grant, be revised as follows:
