### SUMMARY

That the conveyance of interest in the parcel of land for Ridge Road (CR 137) and Langner Road (CR 458) herein described be authorized.

### FISCAL IMPLICATIONS

Erie County is to receive \$17,500 in consideration for the parcel transfer.

### REASONS FOR RECOMMENDATION

The Erie County Lands Advisory Review Committee (ARC) recommends that this approval be granted so that the parcels can be conveyed to the adjoining owner on Ridge Road and Langner Road, Town of West Seneca.

### BACKGROUND INFORMATION

The adjacent property owner at 348 Langner Road wished to purchase the two lots (total 0.196± acre of County highway right-of-way) no longer needed for highway purposes adjacent to their property.

### CONSEQUENCES OF NEGATIVE ACTION

The right-of-way along Ridge Road and Langner Road, Town could not be conveyed and would remain under Erie County's jurisdiction.

### STEPS FOLLOWING APPROVAL

The Department of Public Works, Division of Highways, will convey the lands described herein to the adjacent property owner.

All that piece or parcel of property hereinafter designated as Parcel No. 2, situate in Lot 243, Township 10, Range 7 of the Buffalo Creek Reservation Survey in the Town of West Seneca, County of Erie State of New York, as shown on the accompanying map and described as follows:

**PARCEL NO. 2**

Beginning at a point of intersection of the southerly line of Ridge Road with the westerly line of Langer Road (as located by Map 14, Parcel 16), said point being -11.60 feet northeasterly measured at right angles from Station 2488.46 of the survey baseline; Thence N 89°05'08" W along the aforementioned southerly line of Ridge Road to an angle point known a distance of 45.53 feet to a point -33.75 feet northeasterly measured at right angles from Station 2-28.30 of said survey baseline; Thence S 89°24'52" W along the aforementioned southerly line of Ridge Road a distance of 123.02 feet to a point -24.14 feet northeasterly measured at right angles from Station 1462.74 of said survey baseline; Thence S 27°57'03" W a distance of 13.14 feet to a point -11.03 feet northeasterly measured at right angles from Station 1404.98 of said survey baseline; Thence S 05°33'22" E a distance of 24.73 feet to a point -15.73 feet northeasterly measured at right angles from Station 1424.68 of said survey baseline; Thence S 07°37'02" W a distance of 9.03 feet to a point -0.88 feet northeasterly measured at right angles from Station 1429.04 of said survey baseline; Thence N 08°24'52" E a distance of 140.88 feet to the point of beginning, containing 3,338 square feet, more or less.

Beginning at a point designated as Control Point #1 and monumented with an iron pipe having a station of 0410, thence South 86°06'08" East, a distance of 289.27 feet to a point designated as Control Point #2 and monumented with an iron pipe, having a station of 2-28.87.
