## **SUMMARY**

Approve the attached resolution to revise the State Transportation (AAATRAN) grant budget and related contract for the period April 1, 2011 to March 31, 2012.

### **FISCAL IMPLICATIONS**

The AAATRAN grant is 100% state funded.

## **REASONS FOR RECOMENDATION**

The grant is designed to supplement transportation operating costs, one of which is a contract with the Center for Transportation Excellence to provide wheelchair and other rides for frail elderly individuals ineligible for other transportation.

# **BACKGROUND INFORMATION**

The number of CTE rides increased significantly in the January through March 2012 period and as a result the current contract amount is not sufficient to cover the cost of the trips. The Department desires to increase the amount of the CTE contract in AAATRAN1112 grant to cover the cost of the trips.

# **CONSEQUENCES OF NEGATIVE ACTION**

The Department would be unable to cover all transportation costs provided by CTE.

# **STEPS FOLLOWING APPROVAL**

The Department will revise the AAATRAN1112 budget and increase the related contract with CTE.

WHEREAS, the Erie County Legislature has already appropriated funds for the State Transportation (AAATRAN) grant for the period April 1, 2011 to March 31, 2012; and

WHEREAS, the Department contracts with the Center for Transportation Excellence (CTE) to provide wheelchair and other rides for frail elderly individuals ineligible for other transportation, and the contract amount needs to be increased to cover all such trips authorized by the Department; and

WHEREAS, the current CTE contract is for \$34,050 and is budgeted for in account #516020, Professional Service Contracts and Fees; and

WHEREAS, the AAATRAN1112 grant budget needs to be revised; and

WHEREAS, AAATRAN1112 is a 100% state funded program.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to increase the AAATRAN1112 contract with the Center for Transportation Excellence to \$44,322; and be it further
