SUMMARY

This resolution is seeking your honorable body's authorization for the County Executive to enter into an Agreement Amendment with the engineering firm of Trautman Associates Architects & Engineers for providing Architectural/Engineering services to provide the design and construction documents for the Fire Protection/Sprinkler Standpipe at the Rath County Office Building, 95 Franklin Street.

FISCAL IMPLICATIONS

Funds for the project are currently available from the approved and adopted 2011 Capital budget. The SAP project account is A.11006 – 2011 County Wide Mechanical, Electrical & Plumbing Improvements.

REASON FOR RECOMMENDATION

The New York State Building Code now requires that all high-rise buildings be sprinkler protected throughout the building.

BACKGROUND INFORMATION

The sprinkler standpipe for all floors is the 1st Phase of a multi-phase project to provide sprinklers in the Rath Building.

The Consultant is to prepare plans and specifications in accordance with all codes and regulations.

CONSEQUENCES OF NEGATIVE ACTION

Without the standpipe, sprinklers cannot be installed in the renovated areas.

STEPS FOLLOWING APPROVAL

The County Executive will enter into an Agreement Amendment with the engineering firm of Trautman Associates Architects & Engineers for providing Architectural/Engineering services to provide the design and construction documents so work can commence.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

WHEREAS, this Honorable Body has previously authorized the County Executive to enter into a General Architectural/Engineering Services Agreement with Trautman Associates Architects & Engineers for providing professional design and construction document services on Erie County projects; and

WHEREAS, the County Executive is requesting authorization from your honorable body to issue an Agreement Amendment to Trautman Associates Architects & Engineers for providing design and construction document services for the fire protection/sprinkler standpipe project in the Rath County Office Building;

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is authorized to issue an Agreement Amendment to Trautman Associates Architects & Engineers for providing professional design and construction document services for the fire protection/sprinkler standpipe project in the Rath County Office Building, including reimbursables; and be it further

RESOLVED, that the Comptroller's Office be authorized to make payment for all the above from SAP project account A.11006 – 2011 – Countywide Mechanical, Electrical & Plumbing Improvements for an amount not to exceed \$65,000.00; and be it further

RESOLVED, that two certified copies of this resolution be sent to the Department of Public Works, Commissioner's Office, and one copy each to the Office of the County Executive, the Division of Budget and Management, and the Office of the Comptroller.
