SUMMARY

The Lease between the Buffalo Bills and Erie County requires that the County provide annual capital maintenance and repairs to the Stadium. The Buffalo Bills have requested that the County proceed with Underground Utility Locating Services & Hazardous Materials Testing for 2012. In order for the County to accomplish this, the County Executive is requesting authorization to execute an Agreement Amendment with the Engineering firm of Nussbaumer & Clark, Inc. for Underground Utility Locating Services & Stohl Environmental LLC for Hazardous Materials Testing.

FISCAL IMPLICATIONS

Funds are available from the 2012 approved capital budget, Project A.12001 – 2012- Rehabilitation of Ralph Wilson Stadium.

REASONS FOR RECOMMENDATION

The Buffalo Bills have requested that the County, through the Department of Public Works, proceed with the Underground Utility Locating Services & Hazardous Materials Testing.

BACKGROUND INFORMATION

The County is required pursuant to the Lease between the Buffalo Bills and Erie County to provide annual capital projects. This work complies with the Lease.

CONSEQUENCES OF NEGATIVE ACTION


The County will be in violation of the Lease between the Buffalo Bills and Erie County.

WHEREAS, your Honorable Body has previously approved a general Engineering agreement with the firms of Nussbaumer & Clark, Inc. & Stohl Environmental LLC for providing professional services on County projects; and

WHEREAS, the County Executive is requesting authorization to issue an Agreement Amendment with Nussbaumer & Clarke, Inc. and Stohl Environmental LLC.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive be authorized to issue into an Agreement Amendment with Nussbaumer & Clark, Inc. for Underground Utility Locating Services in an amount not to exceed \$80,000 including reimbursables & Stohl Environmental LLC in an amount not to exceed \$40,000.00 including reimbursables; and be it further

RESOLVED, that the Comptroller's Office be authorized to make payment for all the above from SAP Project Account A.12002-2012 - Rehabilitation of Ralph Wilson Stadium for an amount not to exceed \$120,000; and be it further

RESOLVED, that two certified copies of this resolution be sent to the Department of Public Works, Office of the Commissioner, and one copy each to the Office of the County Executive, the Division of Budget and Management, and the Office of the Comptroller.
