SUMMARY

The Lease between the Buffalo Bills and Erie County requires that the County provide annual capital maintenance and repairs to the Stadium. The Buffalo Bills have requested that the County proceed with capital improvements to the parking lots, roof and old Administration Building HVAC upgrades work. The Department of Public Works has received bids for the Ralph Wilson Stadium-2012 Parking Lot Improvements, Miscellaneous Roof Repairs and Old Administration Building HVAC Upgrades work on June 21, 2012. This resolution is requesting authorization for the County Executive to enter into contracts with the lowest responsible bidders.

FISCAL IMPLICATIONS

Funds are available from the 2011 approved capital budget, SAP Project: A.11002 - 2011 - Rehabilitation of Ralph Wilson Stadium

REASONS FOR RECOMMENDATION

The Buffalo Bills have requested that the County, through the Department of Public Works, proceed with the 2012 capital projects pursuant to the Lease between the Buffalo Bills and Eric County. This work must be started now so the construction can be completed prior to the 2012 football season.

BACKGROUND INFORMATION

The County is required pursuant to the Lease between the Buffalo Bills and Erie County to provide annual capital projects. This work complies with the Lease.

CONSEQUENCES OF NEGATIVE ACTION

The County will be in violation of the Lease between the Buffalo Bills and Eric County.

STEPS FOLLOWING APPROVAL

Contracts will be executed by the County Executive with the lowest responsible bidders so the work can begin. A Contract Amendment will be executed with DiDonato Associates for the additional design work.

COMPTROLLER'S OFFICE REVIEW

For bonds previously sold, the proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

WHEREAS, the Erie County, Department of Public Works, is recommending award of contracts to the lowest responsible bidders, along with the engineer; and

WHEREAS, your Honorable Body has previously approved a general Architectural/Engineering agreement with the engineering firm of DiDonato Associates for providing professional services on County projects; and

WHEREAS, the County Executive is requesting authorization to issue an Agreement Amendment to DiDonato Associates for providing professional design services for the 2012 projects; and

WHEREAS, funds for the project are available from the 2011 bond sale and capital account for Ralph Wilson Stadium.
