SUMMARY

This resolution is requesting authorization for the County Executive to enter into a contract with the lowest responsible bidder for the roof replacement project located at ECC – 45 Oak Street, during the Legislature’s summer recess for an amount not to exceed \$1,750,000.00

FISCAL IMPLICATIONS

Funds for the project are currently from the approved and adopted 2011 Capital Budget, SAP project account E.11003 - 2011-Erie Community College – Roof County Wide. New York State will reimburse the County for 50% of the costs.

REASON FOR RECOMMENDATION

It is necessary that this approval be granted so that the Contract can be awarded to allow the Contractor to begin construction during good weather in the summer months.

BACKGROUND INFORMATION

In order to progress this project during the current construction season and take advantage of the best weather conditions we need to award the contract on a timely basis. However, since your Honorable Body will be on recess shortly, the County Executive is asking for authorization to award a contract to the lowest responsible bidder for an amount not to exceed \$1,750,000.00, including construction contingency.

CONSEQUENCES OF NEGATIVE ACTION

If this project is not completed, the roof will continue to leak and will lead to further deterioration of the building and ultimately closure of the facility because it will become unsafe to occupy.

STEPS FOLLOWING APPROVAL

The County Executive will enter into an Agreement with the lowest responsible bidder for the roof replacement project located at Erie Community College – City Campus - 45 Oak Street when the bids are received during the Legislature’s summer recess.

COMPTROLLER’S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller’s Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

RESOLVED, that the Comptroller's Office be authorized to make payment for all the above from SAP project account E.11003–2011 Erie Community College – Roofs County Wide for an amount not to exceed \$1,750,000.00.

RESOLVED, that two certified copies of this resolution be sent to the Department of Public Works, Commissioner's Office, and one copy each to the Office of the County Executive, the Division of Budget and Management, Erie Community College, Chief Financial Officer and the Office of the Comptroller.
