COMPTROLLER'S

SUMMARY

The legislature has previously authorized the Architectural/Engineering firm of Buffalo Engineering, PC for providing professional design services for the ECC North Campus – Energy Performance Contract. During the course of construction, ECC has requested that additional equipment and controls be replaced. This resolution is seeking authorization for the County Executive to enter into an Agreement Amendment with the Architectural/Engineering firm of Buffalo Engineers, PC for the additional design services.

FISCAL IMPLICATIONS

Funds are available from the approved as amended, 2007 capital budget, SAP Project E.00067 – 2007- ECC North Energy Performance

REASONS FOR RECOMMENDATION

The buildings controls at "K" Building, ECC North Campus, are original to the buildings constructed in the late 1950's. This work will replace existing unit ventilations and controls with new state of the art equipment and controls. The new equipment will reduce maintenance energy costs.

BACKGROUND INFORMATION

The North Campus buildings were constructed in the late 1950's. The original HVAC equipment and controls are failing and not energy efficient. The proposed Architectural/Engineering Agreement Amendment will provide the design for the new equipment and controls.

CONSEQUENCES OF NEGATIVE ACTION

If the existing building's equipment and controls are not replaced, maintenance costs will continue to increase as the original equipment and controls become more unreliable. Maintenance and energy costs savings will not be realized.

STEPS FOLLOWING APPROVAL

An Agreement Amendment will be executed with the firm of Buffalo Engineering, PC, so the design work can proceed.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Comptroller's Office and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.
