Re: Erie County Sheriff's Office

Operation Stonegarden FY 10 and FY 11

WHEREAS, the U.S. Department of Homeland Security through the NYS Division of Homeland Security and Emergency Services has awarded \$190,692 for FY 10 and \$163,765 for FY 11 to Erie County in funding to increase security along the Canadian border; and

WHEREAS, the Erie County Sheriff's Office will coordinate with Police Departments from the Village of Akron, the City of Buffalo, the Town of Cheektowaga, the Town of Evans, the Town of Hamburg, the Niagara Frontier Transit Authority, the City of Tonawanda, the Town of Tonawanda and the Norfolk Southern Rail Road Police to conduct joint law enforcement patrols in support of the U.S. Border Patrol's mission of apprehending terrorists and their weapons as they attempt to enter the United States illegally; and

WHEREAS, these funds will be used for overtime for the participating law enforcement agencies, including the fringe benefits associated with it, and to purchase equipment required to support this program; and

WHEREAS, there will be no impact on County tax dollars.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislatures does hereby authorize the County Executive to enter into contract with the U.S. Department of Homeland Security through the NYS Department of Homeland Security to accept funding in the amount of \$190,692 for FY10 and \$163,765 for FY 11; and be it further

RESOLVED, that the County Executive is authorized to enter into sub-contracts with the participating agencies to reimburse the expenses they incur while participating in the Stonegarden Border Security Operation; and be it further

ACCOMPANYING MEMORANDUM

RE: Erie County Sheriff's Office

Operation Stonegarden FY10 and FY11

I. Summary of Recommended Action

The attached resolution requests authorization for the County of Erie to receive funding in the amount of \$190,692 for FY 10 and \$163,765 for FY 11 from the State of New York Office of Homeland Security for Operation Stonegarden. The mission of Operation Stonegarden is to support the Border Patrol's primary mission of apprehending terrorists and their weapons as they attempt to enter the United States illegally.

II. Fiscal Implications of Proposal

No impact on County Tax Dollars. Funds will provide for all expenses needed to support this program.

III. Reasons for Recommendation

Erie County must maintain its commitment to Homeland Security and continue to prevent, respond and recover from acts of terrorism in this region. The Sheriff's Office will conduct coordinated law enforcement activities with area law enforcement agencies to enhance security of the international border along the Niagara River and Lake Erie.

IV. Consequence of Negative Action

The County will forfeit \$354,457 in funding that will support international border and waterway security. An opportunity to coordinate with U.S. Customs and Border to enhance law enforcement preparedness and operational readiness along the borders of the United States will be lost.

V. Steps Following Approval of Measure
