SUMMARY

The Department of Public Works requests authorization of the transfer of funds between accounts within the 2012 operations budget for the Division of Buildings & Grounds.

FISCAL IMPLICATIONS

There is no fiscal impact from this resolution since the budget is not being increased.

REASONS FOR RECOMMENDATION

The transfer of funds will allow the Division of Buildings and Grounds to purchase equipment necessary to maintain the cleanliness of floors within County-owned buildings located in the downtown area.

BACKGROUND INFORMATION

This Division of Buildings & Grounds initiated a program during 2012 to improve the appearance and cleanliness of various county-owned buildings. The 2012 operations budget did not provide funding in the proper account to allow for the purchase of the needed equipment.

CONSEQUENCES OF NEGATIVE ACTION

The Department will be unable to procure equipment needed to maintain the cleanliness of County-owned buildings.

STEPS FOLLOWING APPROVAL

The Division of Buildings and Grounds will initiate the transfer of funds with the Budget Department. The equipment will be purchased when the funds transfer is completed.

WHEREAS, funding for the equipment is available in Business Area 122, Account 506200 Maintenance and Repair, in the 2012 operations budget; and

WHEREAS, a transfer of funds in the amount of \$15,000 will remedy the funding shortfall and allow for the purchase of the needed cleaning equipment.
