Re: Safe Harbor for Sexually Exploited Children

#### Dear Honorable Members:

The Department has been awarded \$124,444 in 100% State share funds to implement a program entitled Safe Harbor for Sexually Exploited Children. This proposed resolution authorizes the Department to amend the 2012 Adopted Budget and to execute a contract with the International Institute as the lead agency for this program funding. As the State directs that an agency be designated by November 26, 2012 and this service is needed immediately, this proposed resolution seeks Legislative authority to waive section 19.08 of the County Administrative Code which otherwise requires that a Request for Proposals (RFP) be conducted.

In 2008, the State legislature passed the Safe Harbor for Exploited Children Act. A key provision of the Act is to move sexually exploited youth from the criminal and juvenile justice systems to the family court where children and their families can receive support and services from the child welfare system. Services to be provided to child victims of sex trafficking include case management, emergency temporary housing, health care, mental health counseling, language interpretation and translation services, job training and placement and services to assist in establishing permanent residence.

The Erie County Department of Social Services is enlisting the expertise of the International Institute of Buffalo to provide these services. The rationale for selecting the International Institute as a sole provider lies in the fact that the International Institute is currently the only organization in Western New York with a focus speficially on victims of human trafficking. The Institute has staff members dedicated only to trafficking issues, who have become the local experts on how best to serve victims. The International Institute also has an existing network of community partners already on board to provide needed identification, assessment, referrals, and services. In addition, the International Institute co-chairs a task force of local, state, and federal law enforcement providers and community stakeholders. In addition, the Erie County Department of Social Services believes that partnering with the International Institute on this endeavor is the most effective and efficient use of the Safe Harbor funds as this will be a single one time appropriation.
