

SUMMARY

Acceptance and approval of Contract No. 12ST-D, Electrical in the final contract amount of \$98,129.95 together with Change Order No.1 (final) providing a decrease of \$17,270.05 in Erie County Sewer District No. 3 Bond Account C.00067, as well as authorization to issue final payment to the contractor, Weydman Electric, Inc., is requested.

FISCAL IMPLICATIONS

There will be no impact on the County's General Fund. The funds for this contract were allocated from Erie County Sewer District No. 3 Bond Account No. C.00067.

REASONS FOR RECOMMENDATION

All scheduled improvements required by the contract documents have been completed. As a result, it is the Department's recommendation to finalize this contract.

BACKGROUND INFORMATION

Contract No. 12ST-D, Electrical was bid on June 28, 2011 and awarded by the Erie County Legislature on July 21, 2011, Legislative Comm. 13E-14 (2011). This contract installed the electrical work for the dewatered sludge pump replacements at the Southtowns Sewage Treatment Plant.

CONSEQUENCES OF NEGATIVE ACTION


Contract default on the part of the County of Erie could be claimed by the Contactor.

Bid Item D-2, Contingency Allowance is being adjusted from a total of \$20,000.00 to \$2,729.95. One (1) item as outlined on page 2 was paid from the Contingency Allowance in the amount of \$4,027.32 (Attachments #1). One (1) item as outlined on page 2 was credited to the Contingency Allowance in the amount of \$1,297.37 (Attachment #2). The net total final change order cost, is a decrease of \$17,270.05.

Reason for Modification:

In accordance with the contract documents, the Contractor shall be compensated for the work performed and authorized.

Time Extension:

A no cost time extension from September 28, 2012 to June 1, 2013 is being granted to process contract close out. All contract work was completed by March 1, 2013.
