Rybczynski, Town Clerk of the Town of Hamburg, Erie County, New York, do hereby certify that at a regular meeting of the Town Board of the aforesaid Town on the 15th day of July 2013, at the Hamburg Town Hall, 6100 South Park Avenue, Hamburg, New York, the following resolution was adopted, every member present voting therefore, to wit:

Motion of Supervisor Walters, seconded by Councilwoman Ziegler, to adopt the following resolution

WHEREAS, Sowles Road is a very busy thoroughfare as it connects McKinley and Southwestern;

WHEREAS, Sowles is used by the students of Hilbert College, elderly facilities and is resided upon by many citizens of the Town of Hamburg;

WHEREAS, it is not uncommon on a nice day to see children and adults walking and the elderly in wheel chairs in the street, as there are no sidewalks to utilize for safe passage;

WHEREAS, Sowles Road in the Town of Hamburg, New York, is in disrepair and has become a hazard to all drivers utilizing this passageway;

WHEREAS, Tax paying citizens deserve and expect their government and elected officials to not only maintain their roads but keep them safe for travel;

WHEREAS, The County has approximately one million transfer tax money it is holding back;

WHEREAS, this transfer tax money is meant to solely fund highway improvement projects;

NOW THEREFORE BE IT RESOLVED, that the Town of Hamburg calls upon the County of Erie to utilize the necessary portion of the approximately one million dollar transfer tax money to repair and repave Sowles Road from McKinley Parkway to Southwestern Boulevard.

BE IT FURTHER RESOLVED, that certified copies of this resolution be sent to County Executive Mark Poloncarz and Legislator Lynne Dixon.


