

SUMMARY

Acceptance and approval of Contract No. 11-D in the final contract amount of \$34,680.84 together with Change Order No.1 (final) providing a decrease of (\$9,019.16) in Erie County Sewer District No. 8 Bond Account C.00071, as well as authorization to issue final payment to the contractor, Weydman Electric, Inc., is requested.

FISCAL IMPLICATIONS

There will be no impact on the County's General Fund. The funds for this contract were allocated from Erie County Sewer District No. 8 Bond Account No. C.00071.

REASONS FOR RECOMMENDATION

All scheduled improvements required by the contract documents have been completed. As a result, it is the Department's recommendation to finalize this contract.

BACKGROUND INFORMATION

Contract No. 11-D was bid on June 25, 2012 and awarded by the Erie County Legislature on July 19, 2012, Legislative Comm. 11E-13 (2012). This contract installed the electrical work for the Geneva Road Pumping Station.

CONSEQUENCES OF NEGATIVE ACTION


Contract default on the part of the County of Erie could be claimed by the Contactor.

WHEREAS, the Erie County Division of Sewerage Management has advised that all scheduled improvements are now completed; and

WHEREAS, the Erie County Department of Environment and Planning has recommended the acceptance of Contract No. 11-D in the final contract amount of \$34,680.84 which includes Change Order No. 1 (final), a decrease of (\$9,019.16), and recommends approval for final payment.

NOW, THEREFORE BE IT

RESOLVED, that Contract No. 11-D between the County of Erie and Weydman Electric, Inc. (747 Young St. Tonawanda, New York 14150) is accepted in the final contract amount of \$34,680.84 which includes Change Order No. 1 (final), a decrease of (\$9,019.16), and is allocated in Erie County Sewer District No. 8 Bond Account C.00071; and be it further
