## A RESOLUTION TO BE SUBMITTED BY LEGISLATOR GRANT

WHEREAS, this community has come to learn that three separate cases involving the alleged abuse and neglect of vulnerable citizens – two of whom were children, one a mentally challenged adult – resulted in situations that may have compromised the protection of these citizens; and

WHEREAS, although the discipline and/or discharge of county employees involved with these cases was called for – whether front line staff or supervisors – it does not fully address the need for pro-active, preventive measures to be taken within a county government system of protection; and

WHEREAS, the Erie County Community Coordinating Council on Children & Families is in the County Charter and was created to serve as the community's "eyes and ears, hearts and minds" to speak on behalf of the most vulnerable members of our community through their review of best practices and evidence-based advocacy; and

WHEREAS, at this pivotal time for both the child and adult protection systems, it behooves county government to look beyond itself and beyond state government to enlist the help of the community to address this crisis in care for our vulnerable citizens.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature call on the County Executive and the Commissioners and Directors of the various health and human service departments of Erie County government – including but not limited to the Departments of Social Services (including Youth Services), Health, Mental Health, Probation and Senior Services to strengthen the mission and

expand the purview of the Erie County Community Coordinating Council on Children & Families; and be it further

RESOLVED, while this re-invigoration of the Erie County Community Coordinating Council on Children & Families is undertaken, this Honorable Body shall undertake a review of the existing law creating the Council to broaden its scope to include adults – including those who are mentally challenged – that would fall under the purview of Adult Protection; and be it further

RESOLVED, that members of the Council – as outlined in the Local Law – will prioritize a review of the systems in place for the detection and investigation of child abuse and neglect, and an assessment of the systemic response of Child Protective Services; and be it further

RESOLVED, that the Council will also facilitate the inclusion of adult protection as part of its mission, pending passage of a new Local Law to achieve this goal; and be it further

RESOLVED, that the Council will be given sufficient county resources, not limited to inkind support by the participating departments, to conduct its pro-active protective systems review and recommendations on behalf of our community's vulnerable citizens.
