## **REASONS FOR RECOMMENDATION**

The Division of Sewerage Management has issued work order CRA-3 to CRA Infrastructure & Engineering, Inc. to provide Incinerator Emissions Testing of the Southtowns Advanced Wastewater Treatment Facility.

## **BACKGROUND INFORMATION**

On November 8, 2012, the Erie County Legislature passed a resolution authorizing a 3-year Term Agreement with CRA Infrastructure & Engineering, Inc. for engineering services for small and/or time critical projects. At the time of the contract award, the Division of Sewerage Management committed to notifying the Honorable Legislature of each work order issued.

The Term Agreement was approved to provide the Division of Sewerage Management with engineering services required to complete various initiatives throughout the Erie County Sewer Districts. CRA will provide a sampling narrative, sample results, and Laboratory Package associated with incinerator emissions testing at the Southtowns Advanced Wastewater Treatment Facility.
