ACCOMPANYING MEMORANDUM

Re: Victim Witness Assistance Grant

Immediate Consideration Requested

I. Summary of Recommended Action

The proposed resolution and accompanying memorandum request authorization to reallocate funds and upgrades two positions in the Victim Witness Assistance Grant for the 2014 to 2015 grant year, in accordance with the final approved grantor contract.

II. Fiscal Implications of Proposal

Funds in the approved 2014 Erie County District Attorney's Victim Witness Assistance Grant budget are being reallocated to properly reflect the increased spending levels approved by the grantor. There will be a savings of county tax dollars of \$28,632.

III. Reason for Recommendation and Background of Proposal

As a result of a successful grant application submitted to NYS Office of Victim Services, our Office was recently notified that we have been awarded three-year funding levels higher than those received in previous years. NYS OVS has awarded the District Attorney's Office \$382,500 for 2014-2015; \$387,175 for 2015-2016; and \$378,675 for 2016-2017 for our Victim Witness Assistance Program. Part of our grant proposal included the upgrade of our V/W Case Aide and V/W Case Aide-Spanish Speaking from a JG4 to JG5. Since our proposal and increased funding levels have been awarded, we are requesting the upgrades to those two positions. The grant award also includes the funding of overtime costs associated with our ECMC Violent Crime Intervention Project. The increased funding levels allow us to make the above noted changes as well as account for the necessary salary increases resulting from the recently ratified CSEA Union contract, and still net a county share savings of approximately \$28,000.

IV. Consequences of Negative Action

This recommendation will allow the Victim Witness Assistance Grant amounts as listed in the 2014 Budget Book B to be realigned with the final grantor approved appropriation levels. Failure to approve this request could result in the diminished effect of the Victim Witness Assistance Program for the residents of Erie County.

V. Steps Following Approval of Measure

The District Attorney's Office will work with the Division of Budget and Finance to implement this proposal.
