## **SUMMARY**

A new academic building for Erie Community College will soon be in the design phase. The Memorandum of Understanding (MOU) between Erie County and the College concerning the project funding, schedule, and management was adopted by the Erie County Legislature on July 18, 2013. Since \$15,000,000 of the building's cost will be provided by New York State, it is important that the building progress in an expeditious manner. This will insure timely expenditure of State and Local funds. It is therefore requested that an open item be placed on the agenda of the Community Enrichment Committee.
