SUMMARY

The Erie County Legislature is requested to receive and file this communication pertaining to the Department of Environment and Planning's issuance of a work order to DiDonato Associates for Erie County Sewer District No. 5, in the amount of \$29, 980.00.

FISCAL IMPLICATIONS

REASONS FOR RECOMMENDATION

The Division of Sewerage Management has issued work order DA-4 to DiDonato Associates. Under this work order, the consulting engineer will provide the County with additional General Services and Resident Engineering during the construction of the Clarence Research Park Wastewater Treatment Plant upgrade.

BACKGROUND INFORMATION

On November 8, 2012, the Erie County Legislature passed resolution Comm. 18E-9 (2012) authorizing a 3-year Term Agreement with DiDonato Associates. At the time of the contract award, the Division of Sewerage Management committed to notifying the Honorable Legislature of each work order issued.


