SUMMARY

It is recommended that the Legislature authorize the establishment of a grant budget in the amount of \$970,086 for the final two years of a previously approved grant contract with the New York State Office of Indigent Legal Services in the total amount of \$1,455,129.

FISCAL IMPLICATIONS

There are no fiscal implications on the operating budget. All services will be fully reimbursed through New York State in the amount of \$970,086 in the final two years of the grant. \$485,042 of said funds will be utilized by the Erie County Bar Association's Aid to Indigent Prisoners Society and the Legal Aid Bureau of Buffalo will receive \$485,044.

REASONS FOR RECOMMENDATION

Legislative approval is required for the Division of Budget and Management to establish the grant budgets.

BACKGROUND INFORMATION

The New York State Office of Indigent Legal Services made \$1,455,129 available to Erie County to improve the quality of representation provided to indigent defendants. Pursuant to Comm. 20E-12 (2013) the Legislature authorized the acceptance of the grant, establishment of the first year grant budget and the execution of contracts. Further action is necessary to establish the grant budget for the final two years of the grant.

CONSEQUENCES OF NEGATIVE ACTION

Failure to approve this resolution will serve to hinder the improvement of State mandated indigent legal services in Erie County.

STEPS FOLLOWING APPROVAL

Grant budgets will be established by the Division of Budget and Management.
