**RESOLUTION 2015 #279 Support Legislation for the Exemption of Erie County Sales tax for Retail Sale and Installation of Geothermal Heat Pump Systems**

Councilman Cooper moved and Supervisor Dash seconded,

WHEREAS, the Town of Evans supports and commends the passage by the New York State Legislature(A05508 & S04279) into law the exemption for the removal of the States portion of sales tax imposed upon the retail sale of residential and commercial geothermal heat pump systems equipment and the service of installing such systems; and

WHEREAS, the Town of Evans also recognizes Erie County as a leader in Renewable Energy and should be at the forefront of removing the counties portion of said Sales tax for geothermal systems, as such being one of the first counties to do so; and

WHEREFORE the Town Board of the Town of Evans recognizes such legislation passed by the Senate and Assembly of the State of New York as appropriate and to the preservation of the environment, reduction of fossil fuels, to the conservation of natural resources and that all forms of renewable energy are needed to stop Global warming and Climate Change.

RESOLVED, that the Town of Evans hereby formally requests and petitions the County of Erie to remove their portion of the local sales and use tax on the retail sale of residential and commercial geothermal heat pump systems equipment and the service of installing such systems;

AND BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to Legislator John Mills, Legislator Lynne Dixon and to the Legislature of the County of Erie for the consideration of, and action upon, the same.


