### **SUMMARY**

Fleet Feet Sports Buffalo held a fundraiser in September and has presented the Department of Parks, Recreation and Forestry with a donation check of \$400.00. Fleet Feet Sports is a retail store located in North Buffalo that specializes in the fitting of footwear, apparel and accessories for running and walking. They provide training programs for beginners to advanced runners. They also do monthly trail runs in several parks in the Erie County Parks System.

### FISCAL IMPLICATIONS

The Erie County Parks Department will use this \$400.00 donation to enable increased work to occur through the "Pay as You Go" Parks Amenities Capital Project (SAP A.14033). The department would then be able to use such funds for trail maintenance and related park improvement work.

# REASONS FOR RECOMMENDATION/ BACKGROUND INFORMATION

Fleet Feet Sports Buffalo's running group is comprised of park users who wish to enhance their park experience and assist with maintenance by providing funds to cover some of the expenses. Fleet Feet Sports Buffalo hosts monthly trail runs in the Erie County Parks System. They provide a free opportunity for their customers to remain healthy and fit. Fleet Feet Sports hosted a fundraiser and donated \$400.00 to the Erie County Parks Department to assist with trail maintenance and similar projects.
